STRUCTURE OF EXTENSIONS OF FREE ARAKI-WOODS FACTORS

ABSTRACT. — We investigate the structure of crossed product von Neumann algebras arising from Bogoljubov actions of countable groups on Shlyakhtenko's free Araki-Woods factors. Among other results, we settle the questions of factoriality and Connes' type classification. We moreover provide general criteria regarding fullness and strong solidity. As an application of our main results, we obtain examples of type III_0 factors that are prime, have no Cartan subalgebra and possess a maximal amenable abelian subalgebra. We also obtain a new class of strongly solid type III factors with prescribed Connes' invariants that are not isomorphic to any free Araki-Woods factors.

RÉSUMÉ. — Nous étudions la structure de produits croisés d'algèbres de von Neumann provenant des actions Bogoljubov de groupes dénombrables sur les facteurs d'Araki-Woods libres. Nous résolvons notamment les questions concernant la factorialité et la classification du type de Connes. Nous donnons également des critères généraux concernant le caractère plein et la solidité forte. Comme application de nos résultats, nous obtenons des exemples de facteurs de type III_0 qui sont premiers, sans sous-algèbre de Cartan et qui possèdent une sous-algèbre maximale moyennable abélienne. Nous obtenons aussi une nouvelle classe de facteurs fortement solides de type III avec des invariants de Connes prescrits et qui ne sont pas isomorphes à des facteurs d'Araki-Woods libres.

Introduction

A *von Neumann algebra* is a unital $*$ -subalgebra of bounded linear operators on a Hilbert space that is closed with respect to the weak operator topology. By a well-known theorem of von Neumann, in order to understand von Neumann algebras, it is sufficient to classify *factors*, that is, von Neumann algebras with trivial center. Factors can be divided into different

types: I, II and III. By Connes–Tomita–Takesaki modular theory, one can further decompose any type III factor as the crossed product of a type II_∞ von Neumann algebra by a trace scaling action of \mathbf{R} . A central theme in operator algebras is to understand how much information the factor retains from its building data. The *rigidity paradigm* aims at recovering the building data out of the analytic/algebraic structure of the factor.

There is a distinguished class of factors that is completely understood: the class of *amenable* factors. By Connes' celebrated result [11], any amenable factor is *approximately finite dimensional* (AFD), that is, it can be written as the weak closure of an increasing sequence of finite dimensional subalgebras. By the work of Connes [11, 12] and Haagerup [15], amenable factors are completely classified by their type and by their flow of weights. For instance, there is a unique amenable type II_1 factor: it is the AFD type II_1 factor of Murray–von Neumann [37] that we denote by R .

The classification problem of nonamenable factors remained elusive for a long time. However the situation dramatically changed in 2001 when Popa [44, 45, 46] introduced his *deformation/rigidity theory* to study tracial von Neumann algebras and equivalence relations arising from probability measure preserving (pmp) group actions on standard measure spaces. Among landmark results that are also relevant to this paper, Ozawa–Popa [41] showed that free group factors are *strongly solid*, meaning that the normalizer of any diffuse amenable subalgebra stays amenable. Popa–Vaes [47] showed that any free ergodic pmp action of the free groups gives rise to a group measure space construction with a *unique Cartan subalgebra*, up to unitary conjugacy.

The absence of a (faithful normal semifinite) trace makes the study of type III factors extremely difficult. Over the last few years, a *deformation/rigidity theory* for type III factors has emerged, extending Popa's deformation/rigidity theory for type II_1 factors to the realm of type III factors (see e.g. [4, 8, 20, 29]). This novel approach in the study of the structure and the classification of type III factors, combined with Connes–Tomita–Takesaki modular theory, has been very successful, notably in the study of free Araki–Woods factors [6, 23, 24, 26].

Free Araki–Woods factors were introduced by Shlyakhtenko in [49] using Voiculescu's free Gaussian functor [60, 62]. To any strongly continuous orthogonal representation $U : \mathbf{R} \curvearrowright H_{\mathbf{R}}$, one can associate a von Neumann algebra $\Gamma(H_{\mathbf{R}}, U)''$, called the *free Araki–Woods* von Neumann algebra, that is endowed with a canonical faithful normal state φ_U , called the *free*

quasi-free state. We refer the reader to Section 2 for a detailed construction. Using Voiculescu's free probability theory, Shlyakhtenko settled the questions of factoriality, type classification, fullness and Connes' type III invariants for free Araki–Woods von Neumann algebras [49, 50, 51, 52] (see also [58]). When $U = 1_{H_{\mathbf{R}}}$, we have $\Gamma(H_{\mathbf{R}}, 1_{H_{\mathbf{R}}})'' \cong L(\mathbf{F}_{\dim(H_{\mathbf{R}})})$ and so $M = \Gamma(H_{\mathbf{R}}, 1_{H_{\mathbf{R}}})''$ is a free group factor. When $U \neq 1_{H_{\mathbf{R}}}$, $\Gamma(H_{\mathbf{R}}, U)''$ is a full factor of type III. For that reason, free Araki–Woods factors are often regarded as type III analogues of free group factors.

To any countable group G and any orthogonal representation $\pi : G \curvearrowright H_{\mathbf{R}}$ such that U and π commute (abbreviated $[U, \pi] = 0$ hereafter), one can associate the corresponding free Bogoljubov action $\sigma^\pi : G \curvearrowright \Gamma(H_{\mathbf{R}}, U)''$ that preserves the free quasi-free state φ_U . We simply denote the crossed product von Neumann algebra $\Gamma(H_{\mathbf{R}}, U)'' \rtimes G$ by $\Gamma(U, \pi)''$. We refer to the von Neumann algebra $\Gamma(U, \pi)''$ as the *extension* of the free Araki–Woods von Neumann algebra $\Gamma(H_{\mathbf{R}}, U)''$ by the countable group G via the free Bogoljubov action σ^π .

In this paper, we investigate the structure of extensions of free Araki–Woods factors $\Gamma(U, \pi)''$. Among other results, we settle the questions of factoriality and Connes' type classification. We moreover provide general criteria regarding fullness and strong solidity. Our results generalize and strengthen some of the results obtained by the first named author [18] regarding the structure of crossed product type II_1 factors arising from free Bogoljubov actions of countable groups on free group factors. Moreover, we apply our results to obtain new classes of type III factors with various structural properties such as the existence of maximal amenable abelian subalgebras or the property of strong solidity, to name a few. All locally compact groups are assumed to be second countable and all (real) Hilbert spaces are assumed to be separable, unless stated otherwise.

1. Statement of the main results

Factoriality and Connes' type classification

Our first result settles the questions of factoriality and Connes' type classification of extensions of free Araki–Woods factors $\Gamma(U, \pi)''$. Let G be any countable group. For every $g \in G$, we denote by $C(g) = \{hgh^{-1} \mid h \in G\}$ the conjugacy class of $g \in G$. Recall that the FC-radical of G is defined by $\text{FC}(G) = \{g \in G \mid |C(g)| < +\infty\}$. Observe that $\mathcal{Z}(G) < \text{FC}(G) < G$, where $\mathcal{Z}(G)$ denotes the center of G .

THEOREM A. — *Let $U : \mathbf{R} \curvearrowright H_{\mathbf{R}}$ be any strongly continuous orthogonal representation with $\dim H_{\mathbf{R}} \geq 2$. Let G be any countable group and $\pi : G \curvearrowright H_{\mathbf{R}}$ any orthogonal representation such that $[U, \pi] = 0$. Put $M = \Gamma(U, \pi)''$. The following assertions hold.*

- (i) *M is a factor if and only if $\pi_g \neq 1$ for every $g \in \text{FC}(G) \setminus \{e\}$.*
- (ii) *Assume that M is a factor. Then*

$$T(M) = \{t \in \mathbf{R} \mid \exists g \in \mathcal{Z}(G) \text{ such that } U_t = \pi_g\}.$$

- (iii) *When M is a factor, Connes' invariant $T(M)$ completely determines the type of M .*

$$M \text{ is of type III}_1 \iff T(M) = \{0\}$$

$$M \text{ is of type III}_\lambda \iff T(M) = \frac{2\pi}{\log \lambda} \mathbf{Z} \quad \text{with } 0 < \lambda < 1$$

$$M \text{ is of type III}_0 \iff T(M) \text{ is dense in } \mathbf{R} \text{ and } T(M) \neq \mathbf{R}$$

$$M \text{ is of type II}_1 \iff T(M) = \mathbf{R}$$

- (iv) *When M is a type III₁ factor, M has trivial bicentralizer.*

One of the key elements of the proof of Theorem A is the fact that whenever $\pi \in \mathcal{O}(H_{\mathbf{R}})$ is a nontrivial orthogonal transformation that commutes with U , the corresponding Bogoljubov automorphism $\sigma^\pi \in \text{Aut}(\Gamma(H_{\mathbf{R}}, U))''$ is not inner (see Lemma 3.2).

Fullness and Connes' τ invariant

Whenever G is a locally compact group and $\rho : G \curvearrowright H_{\mathbf{R}}$ is a strongly continuous orthogonal representation, we define $\tau(\rho)$ as the weakest topology on G that makes ρ continuous. When G is countable, we simply denote by τ_G the discrete topology on G . Following [10], we say that a factor with separable predual M is *full* if the subgroup of inner automorphisms $\text{Inn}(M)$ is closed in the group of all $*$ -automorphisms $\text{Aut}(M)$. If M is full, Connes' τ invariant $\tau(M)$ is defined as the weakest topology on \mathbf{R} that makes the modular homomorphism $\delta_M : \mathbf{R} \rightarrow \text{Out}(M)$ continuous.

Our second result shows that the extension $\Gamma(U, \pi)''$ is a full factor whenever π is faithful and $\pi(G)$ is discrete in $\mathcal{O}(H_{\mathbf{R}})$ with respect to the strong topology. This result extends [18, Theorem A] to the type III setting. Assuming moreover that G is infinite and that the weakest topology on $\mathbf{R} \times G$ that makes the representation $\rho : \mathbf{R} \times G \curvearrowright H_{\mathbf{R}}$ continuous is $\tau(U) \times \tau_G$, we can compute Connes' invariant $\tau(M)$. This phenomenon is unique to the type III setting and has no analogue in the realm of type II₁ factors.

THEOREM B. — *Let $U : \mathbf{R} \curvearrowright H_{\mathbf{R}}$ be any strongly continuous orthogonal representation with $\dim H_{\mathbf{R}} \geq 2$. Let G be any countable group and $\pi : G \curvearrowright H_{\mathbf{R}}$ any faithful orthogonal representation such that $[U, \pi] = 0$. Define the strongly continuous orthogonal representation $\rho : \mathbf{R} \times G \curvearrowright H_{\mathbf{R}}$ by $\rho_{(t,g)} = U_t \pi_g$ for every $t \in \mathbf{R}$ and every $g \in G$. Put $M = \Gamma(U, \pi)''$.*

- (i) *Assume that $\tau(\pi) = \tau_G$. Then M is a full factor.*
- (ii) *Assume that G is infinite and that $\tau(\rho) = \tau(U) \times \tau_G$. Then M is a full factor and $\tau(M) = \tau(U)$.*

The proof of Theorem B uses a combination of Popa's asymptotic orthogonality property [43], ε -orthogonality techniques [17, 18] and modular theory of ultraproduct von Neumann algebras [2].

We should point out that Theorem B does not rely on Marrakchi's result [36, Theorem B] (see also [33] for the tracial case). Recall that for any full factor N , any countable group G and any outer action $\sigma : G \curvearrowright N$ such that the image of $\sigma(G)$ is discrete in $\text{Out}(N)$, the crossed product $M = N \rtimes G$ is a full factor by [36, Theorem B]. The condition that the image of $\sigma(G)$ is discrete in $\text{Out}(N)$ is rather difficult to check in general as it requires to understand the quotient group $\text{Out}(N)$. For the class of Bogoljubov actions $\sigma^\pi : G \curvearrowright N$, where $N = \Gamma(H_{\mathbf{R}}, U)''$, our Theorem B shows that the crossed product $N \rtimes G$ is a full factor under the weaker assumption that $\pi(G)$ is discrete in $\mathcal{O}(H_{\mathbf{R}})$ with respect to the strong topology, or equivalently, that $\sigma^\pi(G)$ is discrete in $\text{Aut}(N)$ with respect to the u -topology.

When the countable group G is *amenable*, combining our Theorem B, [22, Theorem 3.6] and Marrakchi's very recent result [35, Theorem A], we obtain the following characterization.

COROLLARY. — *Let $U : \mathbf{R} \curvearrowright H_{\mathbf{R}}$ be any strongly continuous orthogonal representation with $\dim H_{\mathbf{R}} \geq 2$. Let G be any amenable countable group and $\pi : G \curvearrowright H_{\mathbf{R}}$ any faithful orthogonal representation such that $[U, \pi] = 0$. Put $N = \Gamma(H_{\mathbf{R}}, U)'' \subset \Gamma(U, \pi)'' = M$. The following assertions are equivalent.*

- (i) $\tau(\pi) = \tau_G$.
- (ii) *The image of $\sigma^\pi(G)$ is discrete in $\text{Out}(N)$.*
- (iii) *M is a full factor.*
- (iv) *For every directed set I and every cofinal ultrafilter ω on I , we have $N' \cap M^\omega = \mathbf{C}1$.*

Amenable and Gamma absorption

Next, we investigate absorption properties of the inclusion $L(G) \subset \Gamma(U, \pi)''$ with respect to amenable and/or Gamma subalgebras. Recall that a σ -finite von Neumann algebra N is said to have *property Gamma* if the central sequence algebra $N' \cap N^\omega$ is diffuse for some (or any) nonprincipal ultrafilter $\omega \in \beta(\mathbf{N}) \setminus \mathbf{N}$. Recall also that a von Neumann subalgebra $P \subset M$ is said to be *with expectation* if there exists a faithful normal conditional expectation $E_P : M \rightarrow P$. Our next result extends and strengthens [18, Theorems D and E] to the type III setting.

THEOREM C. — *Let $U : \mathbf{R} \curvearrowright H_{\mathbf{R}}$ be any strongly continuous orthogonal representation. Let G be any countable group and $\pi : G \curvearrowright H_{\mathbf{R}}$ any orthogonal representation such that $[U, \pi] = 0$. Put $M = \Gamma(U, \pi)''$.*

- (i) *Assume that $\pi : G \curvearrowright H_{\mathbf{R}}$ is weakly mixing. Let $L(G) \subset P \subset M$ be any intermediate von Neumann subalgebra with expectation such that P is amenable relative to $L(G)$ inside M . Then $P = L(G)$.*
- (ii) *Assume that $\pi : G \curvearrowright H_{\mathbf{R}}$ is mixing. Let $P \subset M$ be any von Neumann subalgebra with expectation and with property Gamma such that $P \cap L(G)$ is diffuse. Then $P \subset L(G)$.*

The proof of Theorem C relies on [34, Theorem 5.1] and [28, Theorem 3.1] as well as mixing techniques for inclusions of von Neumann algebras (see Appendix A). Note that item (ii) of Theorem C can also be regarded as a strengthening of item (i) of Theorem B in the case when π is *mixing*.

Using Theorem C as well as Theorems 6.1 and 6.2, we obtain examples of type III₀ factors, with prescribed Connes' T invariant, that are prime, have no Cartan subalgebra and possess a maximal amenable abelian subalgebra.

APPLICATION D. — *Let $U : \mathbf{R} \curvearrowright H_{\mathbf{R}}$ be any mixing strongly continuous orthogonal representation. Let $G \subset \mathbf{R}$ be any countable dense subgroup and put $\pi = U|_G$.*

Then $M = \Gamma(U, \pi)''$ is a type III₀ factor such that $T(M) = G$. Moreover, M is prime, M has no Cartan subalgebra and $L(G) \subset M$ is maximal amenable.

We would like to point out that all previously known examples of maximal amenable abelian subalgebras with expectation $A \subset M$ in type III factors (see [4, 19, 27]) require the intermediate amenable subalgebra $A \subset P \subset M$ to be also with expectation. That is why the terminology “maximal amenable with expectation” was used in [4, 19, 27]. Application D provides the first concrete class of abelian subalgebras with expectation in type III

factors that are *genuinely* maximal amenable, that is, with no further assumption on the intermediate amenable subalgebra $A \subset P \subset M$. Indeed, for the inclusions in Application D, any intermediate von Neumann subalgebra $L(G) \subset P \subset M$ is automatically with expectation and so we may apply Theorem C.

Strong solidity

Following [6, 41], a σ -finite von Neumann algebra N is said to be *strongly solid* if for any diffuse amenable subalgebra with expectation $Q \subset N$, the normalizer $\mathcal{N}_N(Q)'' \subset N$ of Q inside N stays amenable, where $\mathcal{N}_N(Q) = \{u \in \mathcal{U}(N) \mid uQu^* = Q\}$. In their breakthrough article [41], Ozawa–Popa famously proved that free group factors are strongly solid. These were the first class of strongly solid type II_1 factors in the literature. Recently, generalizing the methods of Ozawa–Popa, Boutonnet–Houdayer–Vaes [6] showed that free Araki–Woods factors are strongly solid, thus obtaining the first class of strongly solid type III factors.

Our next result shows that when G is amenable and π is faithful and mixing, the extension $\Gamma(U, \pi)''$ is strongly solid. We refer the reader to [7, 32] for other examples of strongly solid type III factors.

THEOREM E. — *Let $U : \mathbf{R} \curvearrowright H_{\mathbf{R}}$ be any strongly continuous orthogonal representation. Let G be any amenable countable group and $\pi : G \curvearrowright H_{\mathbf{R}}$ any faithful mixing orthogonal representation such that $[U, \pi] = 0$.*

Then $\Gamma(U, \pi)''$ is a strongly solid factor.

The proof of Theorem E uses Popa’s deformation/rigidity theory. More precisely, it relies on [6, Theorem 3.7] and [32, Theorem A] as well as mixing techniques for inclusions of von Neumann algebras (see Appendix A).

We use Theorem E to obtain a new class of strongly solid type III factors, with prescribed Connes’ invariants, that are not isomorphic to any free Araki–Woods factor.

APPLICATION F. — *Let $U : \mathbf{R} \curvearrowright H_{\mathbf{R}}$ be any strongly continuous orthogonal representation such that $U \neq 1_{H_{\mathbf{R}}}$ and such that U has a nonzero invariant vector. Let $\pi : \mathbf{Z} \curvearrowright K_{\mathbf{R}}$ be any mixing orthogonal representation such that the spectral measure of $\bigoplus_{n \geq 1} \pi^{\otimes n}$ is singular with respect to the Haar measure on \mathbf{T} .*

Put $M = \Gamma(U \otimes 1_{K_{\mathbf{R}}}, 1_{H_{\mathbf{R}}} \otimes \pi)''$. Then M is a strongly solid type III factor that has the complete metric approximation property and the Haagerup

property and such that $T(M) = \ker(U)$ and $\tau(M) = \tau(U)$. Moreover, M is not isomorphic to any free Araki–Woods factor.

2. Preliminaries

2.1. Background on σ -finite von Neumann algebra

For any von Neumann algebra M , we denote by $\mathcal{Z}(M)$ its centre, by $\mathcal{U}(M)$ its group of unitaries, by $\text{Ball}(M)$ its unit ball with respect to the uniform norm $\|\cdot\|_\infty$ and by $(M, L^2(M), J, L^2(M)_+)$ its standard form [14].

Let M be any σ -finite von Neumann algebra and $\varphi \in M_*$ any faithful state. We write $\|x\|_\varphi = \varphi(x^*x)^{1/2}$ for every $x \in M$. Recall that on $\text{Ball}(M)$, the topology given by $\|\cdot\|_\varphi$ coincides with the strong topology. We denote by $\xi_\varphi = \varphi^{1/2} \in L^2(M)_+$ the unique element such that $\varphi = \langle \cdot, \xi_\varphi, \xi_\varphi \rangle$. Conversely, for every $\xi \in L^2(M)_+$, we denote by $\varphi_\xi = \langle \cdot, \xi, \xi \rangle \in M_*$ the corresponding positive form. The mapping $M \rightarrow L^2(M) : x \mapsto x\xi_\varphi$ defines an embedding with dense image such that $\|x\|_\varphi = \|x\xi_\varphi\|$ for all $x \in M$.

Let M be any σ -finite von Neumann algebra and $\varphi \in M_*$ any faithful state. We denote by σ^φ the modular automorphism group of the state φ . The centralizer M_φ of the state φ is by definition the fixed point algebra of (M, σ^φ) . The *continuous core* of M with respect to φ , denoted by $c_\varphi(M)$, is the crossed product von Neumann algebra $M \rtimes_{\sigma^\varphi} \mathbf{R}$. The natural inclusion $\pi_\varphi : M \rightarrow c_\varphi(M)$ and the unitary representation $\lambda_\varphi : \mathbf{R} \rightarrow c_\varphi(M)$ satisfy the *covariance* relation

$$\forall x \in M, \forall t \in \mathbf{R}, \quad \lambda_\varphi(t)\pi_\varphi(x)\lambda_\varphi(t)^* = \pi_\varphi(\sigma_t^\varphi(x)).$$

Put $L_\varphi(\mathbf{R}) = \lambda_\varphi(\mathbf{R})''$. There is a unique faithful normal conditional expectation $E_{L_\varphi(\mathbf{R})} : c_\varphi(M) \rightarrow L_\varphi(\mathbf{R})$ satisfying $E_{L_\varphi(\mathbf{R})}(\pi_\varphi(x)\lambda_\varphi(t)) = \varphi(x)\lambda_\varphi(t)$. The faithful normal semifinite weight $L^\infty(\mathbf{R})^+ \rightarrow [0, +\infty] : f \mapsto \int_{\mathbf{R}} \exp(-s)f(s) ds$ gives rise to a faithful normal semifinite weight

Tr_φ on $L_\varphi(\mathbf{R})$ via the Fourier transform. The formula $\text{Tr}_\varphi = \text{Tr}_\varphi \circ E_{L_\varphi(\mathbf{R})}$ extends it to a faithful normal semifinite trace on $c_\varphi(M)$.

Because of Connes' Radon–Nikodym cocycle theorem [9, Théorème 1.2.1] (see also [55, Theorem VIII.3.3]), the semifinite von Neumann algebra $c_\varphi(M)$ together with its trace Tr_φ does not depend on the choice of φ in the following precise sense. If ψ is another faithful normal state on M , there is a canonical surjective $*$ -isomorphism $\Pi_{\varphi,\psi} : c_\psi(M) \rightarrow c_\varphi(M)$ such that $\Pi_{\varphi,\psi} \circ \pi_\psi = \pi_\varphi$ and $\text{Tr}_\varphi \circ \Pi_{\varphi,\psi} = \text{Tr}_\psi$. Note however that $\Pi_{\varphi,\psi}$ does not map the subalgebra $L_\psi(\mathbf{R}) \subset c_\psi(M)$ onto the subalgebra $L_\varphi(\mathbf{R}) \subset c_\varphi(M)$ (and thus we use the symbol $L_\varphi(\mathbf{R})$ instead of the usual $L(\mathbf{R})$).

2.2. Ultraproduct von Neumann algebras

Let M be any σ -finite von Neumann algebra. Let J be any nonempty directed set and ω any cofinal ultrafilter on J , that is, for all $j_0 \in J$, we have $\{j \in J : j \geq j_0\} \in \omega$. Define

$$\begin{aligned} \mathfrak{I}_\omega(M) &= \left\{ (x_j)_j \in \ell^\infty(J, M) \mid \lim_{j \rightarrow \omega} \|x_j \zeta\| = \lim_{j \rightarrow \omega} \|\zeta x_j\| = 0, \forall \zeta \in L^2(M) \right\} \\ \mathfrak{M}^\omega(M) &= \left\{ (x_j)_j \in \ell^\infty(J, M) \mid \begin{array}{l} (x_j)_j \mathfrak{I}_\omega(M) \subset \mathfrak{I}_\omega(M) \\ \text{and } \mathfrak{I}_\omega(M) (x_j)_j \subset \mathfrak{I}_\omega(M) \end{array} \right\}. \end{aligned}$$

Observe that $\mathfrak{I}_\omega(M) \subset \mathfrak{M}^\omega(M)$. The multiplier algebra $\mathfrak{M}^\omega(M)$ is a C^* -algebra and $\mathfrak{I}_\omega(M) \subset \mathfrak{M}^\omega(M)$ is a norm closed two-sided ideal. Following [38, Section 5.1], we define the ultraproduct von Neumann algebra by $M^\omega = \mathfrak{M}^\omega(M)/\mathfrak{I}_\omega(M)$, which is indeed known to be a von Neumann algebra. Observe that the proof given in [38, 5.1] for the case when $J = \mathbf{N}$ and $\omega \in \beta(\mathbf{N}) \setminus \mathbf{N}$ applies *mutatis mutandis*. We denote the image of $(x_j)_j \in \mathfrak{M}^\omega(M)$ by $(x_j)^\omega \in M^\omega$.

2.3. Extensions of free Araki–Woods factors

Let $U : \mathbf{R} \curvearrowright H_{\mathbf{R}}$ be any strongly continuous orthogonal representation. Denote by $H = H_{\mathbf{R}} \otimes_{\mathbf{C}} \mathbf{C} = H_{\mathbf{R}} \oplus iH_{\mathbf{R}}$ the complexified Hilbert space, by $I : H \rightarrow H : \xi + i\eta \mapsto \xi - i\eta$ the canonical involution on H and by A the infinitesimal generator of $U : \mathbf{R} \curvearrowright H$, that is, $U_t = A^{it}$ for all $t \in \mathbf{R}$. We have $|A| = A^{-1}$. Observe that $j : H_{\mathbf{R}} \rightarrow H : \zeta \mapsto (\frac{2}{A^{-1}+1})^{1/2} \zeta$ defines an isometric embedding of $H_{\mathbf{R}}$ into H . Put $K_{\mathbf{R}} = j(H_{\mathbf{R}})$. It is easy to see that $K_{\mathbf{R}} \cap iK_{\mathbf{R}} = \{0\}$ and that $K_{\mathbf{R}} + iK_{\mathbf{R}}$ is dense in H . Write $T = IA^{-1/2}$.

Then T is a conjugate-linear closed invertible operator on H satisfying $T = T^{-1}$ and $T^*T = A^{-1}$. Such an operator is called an *involution* on H . Moreover, we have $\text{dom}(T) = \text{dom}(A^{-1/2})$ and $K_{\mathbf{R}} = \{\xi \in \text{dom}(T) \mid T\xi = \xi\}$. In what follows, we simply write

$$\forall \xi, \eta \in K_{\mathbf{R}}, \quad \overline{\xi + i\eta} = T(\xi + i\eta) = \xi - i\eta.$$

We introduce the *full Fock space* of H by

$$\mathcal{F}(H) = \mathbf{C}\Omega \oplus \bigoplus_{n=1}^{\infty} H^{\otimes n}.$$

The unit vector Ω is called the *vacuum vector*. For all $\xi \in H$, define the *left creation operator* $\ell(\xi) : \mathcal{F}(H) \rightarrow \mathcal{F}(H)$ by

$$\begin{cases} \ell(\xi)\Omega = \xi \\ \ell(\xi)(\xi_1 \otimes \cdots \otimes \xi_n) = \xi \otimes \xi_1 \otimes \cdots \otimes \xi_n. \end{cases}$$

We have $\|\ell(\xi)\|_{\infty} = \|\xi\|$ and $\ell(\xi)$ is an isometry if $\|\xi\| = 1$. For all $\xi \in K_{\mathbf{R}}$, put $W(\xi) = \ell(\xi) + \ell(\xi)^*$. The crucial result of Voiculescu [62, Lemma 2.6.3] is that the distribution of the self-adjoint operator $W(\xi)$ with respect to the vector state $\varphi_U = \langle \cdot, \Omega \rangle$ is the semicircular law of Wigner supported on the interval $[-\|\xi\|, \|\xi\|]$.

Following [49], the *free Araki-Woods* von Neumann algebra associated with $U : \mathbf{R} \curvearrowright H_{\mathbf{R}}$ is defined by

$$\Gamma(H_{\mathbf{R}}, U)'' = \{W(\xi) \mid \xi \in K_{\mathbf{R}}\}''.$$

The vector state $\varphi_U = \langle \cdot, \Omega \rangle$ is called the *free quasi-free state* and is faithful on $\Gamma(H_{\mathbf{R}}, U)''$. Let $\xi, \eta \in K_{\mathbf{R}}$ and write $\zeta = \xi + i\eta$. Put

$$W(\zeta) = W(\xi) + iW(\eta) = \ell(\zeta) + \ell(\bar{\zeta})^*.$$

It is easy to see that for all $n \geq 1$ and all $\zeta_1, \dots, \zeta_n \in K_{\mathbf{R}} + iK_{\mathbf{R}}$, $\zeta_1 \otimes \cdots \otimes \zeta_n \in \Gamma(H_{\mathbf{R}}, U)''\Omega$. When ζ_1, \dots, ζ_n are all nonzero, we will denote by $W(\zeta_1 \otimes \cdots \otimes \zeta_n) \in \Gamma(H_{\mathbf{R}}, U)''$ the unique element such that

$$\zeta_1 \otimes \cdots \otimes \zeta_n = W(\zeta_1 \otimes \cdots \otimes \zeta_n)\Omega.$$

Such an element is called a *reduced word*. By [23, Proposition 2.1 (i)] (see also [17, Proposition 2.4]), the reduced word $W(\zeta_1 \otimes \cdots \otimes \zeta_n)$ satisfies the *Wick formula* given by

$$W(\zeta_1 \otimes \cdots \otimes \zeta_n) = \sum_{k=0}^n \ell(\zeta_1) \cdots \ell(\zeta_k) \ell(\bar{\zeta}_{k+1})^* \cdots \ell(\bar{\zeta}_n)^*.$$

Since inner products are assumed to be linear in the first variable, we have $\ell(\xi)^*\ell(\eta) = \overline{\langle \xi, \eta \rangle}1 = \langle \eta, \xi \rangle 1$ for all $\xi, \eta \in H$. In particular, the Wick formula from [23, Proposition 2.1 (ii)] is

$$\begin{aligned} W(\xi_1 \otimes \cdots \otimes \xi_r)W(\eta_1 \otimes \cdots \otimes \eta_s) \\ = W(\xi_1 \otimes \cdots \otimes \xi_r \otimes \eta_1 \otimes \cdots \otimes \eta_s) \\ + \overline{\langle \xi_r, \eta_1 \rangle} W(\xi_1 \otimes \cdots \otimes \xi_{r-1})W(\eta_2 \otimes \cdots \otimes \eta_s) \end{aligned}$$

for all $\xi_1, \dots, \xi_r, \eta_1, \dots, \eta_s \in K_{\mathbf{R}} + iK_{\mathbf{R}}$. We will repeatedly use this fact throughout. We refer to [23, Section 2] for further details.

The modular automorphism group σ^{φ_U} of the free quasi-free state φ_U is given by $\sigma_t^{\varphi_U} = \text{Ad}(\mathcal{F}(U_t))$, where $\mathcal{F}(U_t) = 1_{\mathbf{C}\Omega} \oplus \bigoplus_{n \geq 1} U_t^{\otimes n}$. In particular, it satisfies

$$\begin{aligned} \forall n \in \mathbf{N}, \forall \zeta_1, \dots, \zeta_n \in K_{\mathbf{R}} + iK_{\mathbf{R}}, \forall t \in \mathbf{R}, \\ \sigma_t^{\varphi_U}(W(\zeta_1 \otimes \cdots \otimes \zeta_n)) = W(U_t \zeta_1 \otimes \cdots \otimes U_t \zeta_n). \end{aligned}$$

Let now G be any countable group and $\pi : G \curvearrowright H_{\mathbf{R}}$ any orthogonal representation such that U and π commute (hereafter abbreviated $[U, \pi] = 0$). Denote by $\pi : G \curvearrowright H$ the corresponding unitary representation. Using the Wick formula, for all $n \geq 0$, all $\zeta_1, \dots, \zeta_n \in K_{\mathbf{R}} + iK_{\mathbf{R}}$ and all $g \in G$, we have

$$\text{Ad}(\mathcal{F}(\pi_g))(W(\zeta_1 \otimes \cdots \otimes \zeta_n)) = W(\pi_g(\zeta_1) \otimes \cdots \otimes \pi_g(\zeta_n)).$$

The action $\text{Ad}(\mathcal{F}(\pi)) : G \curvearrowright \mathbf{B}(\mathcal{F}(H))$ leaves the free Araki–Woods von Neumann algebra $\Gamma(H_{\mathbf{R}}, U)''$ globally invariant. We use the following terminology.

DEFINITION 2.1. — *The action $\sigma^\pi : G \curvearrowright \Gamma(H_{\mathbf{R}}, U)''$ defined by $\sigma_g^\pi = \text{Ad}(\mathcal{F}(\pi_g))$ for every $g \in G$ is called the free Bogoljubov action associated with the orthogonal representation $\pi : G \curvearrowright H_{\mathbf{R}}$. The action σ^π preserves the quasi-free state φ_U and commute with its modular automorphism group σ^{φ_U} , that is,*

$$\forall g \in G, \forall t \in \mathbf{R}, \quad \varphi_U = \varphi_U \circ \sigma_g^\pi \quad \text{and} \quad \sigma_t^{\varphi_U} \circ \sigma_g^\pi = \sigma_g^\pi \circ \sigma_t^{\varphi_U}.$$

We simply denote by $\Gamma(U, \pi)'' = \Gamma(H_{\mathbf{R}}, U)'' \rtimes_{\sigma^\pi} G$ the corresponding crossed product von Neumann algebra. We refer to $\Gamma(U, \pi)''$ as the extension of the free Araki–Woods von Neumann algebra $\Gamma(H_{\mathbf{R}}, U)''$ by the countable group G via the free Bogoljubov action $\sigma^\pi : G \curvearrowright \Gamma(H_{\mathbf{R}}, U)''$. Put $N = \Gamma(H_{\mathbf{R}}, U)''$ and $M = \Gamma(U, \pi)''$ so that $M = N \rtimes G$. Denote by $E_N : M \rightarrow N$ the canonical faithful normal conditional expectation and

by $\varphi = \varphi_U \circ E_N$ the canonical faithful normal state on M . We identify the standard form $L^2(M)$ with $\mathcal{F}(H) \otimes \ell^2(G)$ via the unitary mapping

$$U : L^2(M) \rightarrow \mathcal{F}(H) \otimes \ell^2(G) : W(\zeta_1 \otimes \cdots \otimes \zeta_n) u_g \xi_\varphi \mapsto \zeta_1 \otimes \cdots \otimes \zeta_n \otimes \delta_g$$

where $n \geq 0$, $\zeta_1, \dots, \zeta_n \in K_{\mathbf{R}} + iK_{\mathbf{R}}$, $g \in G$.

2.4. Intertwining theory

Let M be any σ -finite von Neumann algebra and $A \subset 1_A M 1_A$, $B \subset 1_B M 1_B$ any von Neumann subalgebras with expectation. Following [20, 44, 45], we say that A embeds with expectation into B inside M and write $A \preceq_M B$, if there exist projections $e \in A$ and $f \in B$, a nonzero partial isometry $v \in eMf$ and a unital normal $*$ -homomorphism $\theta : eAe \rightarrow fBf$ such that the inclusion $\theta(eAe) \subset fBf$ is with expectation and $av = v\theta(a)$ for all $a \in eAe$.

We will need the following technical result that is essentially contained in [29, Lemma 2.6].

LEMMA 2.2. — *Let M be any von Neumann algebra with separable predual. Let $A \subset 1_A M 1_A$, $B \subset M$ be any von Neumann subalgebras with expectation. Assume that B is of type I. If $A \not\preceq_M B$, there exists a diffuse abelian subalgebra with expectation $D \subset A$ such that $D \not\preceq_M B$.*

Proof. — The proof of [29, Lemma 2.6] applies *mutatis mutandis* to the case when B is a type I von Neumann algebra. \square

2.5. Relative amenability

Let M be any σ -finite von Neumann algebra and $A \subset 1_A M 1_A$, $B \subset M$ any von Neumann subalgebras with expectation. Following [41, 21], we say that A is amenable relative to B inside M and write $A \triangleleft_M B$ if there exists a conditional expectation $\Phi : 1_A \langle M, B \rangle 1_A \rightarrow A$ such that the restriction $\Phi|_{1_A M 1_A} : 1_A M 1_A \rightarrow A$ is faithful and normal.

Fix now $E_A : 1_A M 1_A \rightarrow A$ a faithful normal conditional expectation. Using [31, Remark 3.3], $A \triangleleft_M B$ if and only if there exists a conditional expectation $\Phi : 1_A \langle M, B \rangle 1_A \rightarrow A$ such that $\Phi|_{1_A M 1_A} = E_A$.

3. Factoriality and Connes' type classification

We start by proving the following well known fact about orthogonal representations of abelian locally compact second countable (lcsc) groups.

PROPOSITION 3.1. — *Let G be any abelian lcsc group and $\rho : G \curvearrowright H_{\mathbf{R}}$ any irreducible strongly continuous orthogonal representation. Then $\dim(H_{\mathbf{R}}) \in \{1, 2\}$.*

If $\dim(H_{\mathbf{R}}) = 1$, there exists a continuous homomorphism $\varepsilon : G \rightarrow \{-1, 1\}$ such that for all $g \in G$, we have $\rho_g = \varepsilon_g 1_{H_{\mathbf{R}}}$.

If $\dim(H_{\mathbf{R}}) = 2$, there exist a Borel map $\psi : G \rightarrow \mathbf{R}$ such that for all $g, h \in G$, we have $\psi(gh) - \psi(g) - \psi(h) \in 2\pi\mathbf{Z}$, and there exists an orthonormal basis of $H_{\mathbf{R}}$ such that $\rho : G \curvearrowright H_{\mathbf{R}}$ has the following form:

$$\forall g \in G, \quad \rho_g = \begin{pmatrix} \cos(\psi(g)) & \sin(\psi(g)) \\ -\sin(\psi(g)) & \cos(\psi(g)) \end{pmatrix}.$$

Proof. — We denote by $\rho_{\mathbf{C}} : G \curvearrowright H_{\mathbf{C}}$ the complexified strongly continuous unitary representation. Denote by $J : H_{\mathbf{C}} \rightarrow H_{\mathbf{C}}$ the canonical conjugation. Observe that $\rho_{\mathbf{C}}(g)J = J\rho_{\mathbf{C}}(g)$ for every $g \in G$. The fact that the orthogonal representation ρ is irreducible translates into the following fact for $\rho_{\mathbf{C}}$: the only closed subspaces of $H_{\mathbf{C}}$ that are invariant under both $\rho_{\mathbf{C}}(G)$ and J are $\{0\}$ and $H_{\mathbf{C}}$.

Since G is an abelian lcsc group, we may consider the spectral measure $E_{\rho_{\mathbf{C}}} : \mathcal{B}(\widehat{G}) \rightarrow \mathcal{P}(H_{\mathbf{C}})$ where $\mathcal{B}(\widehat{G})$ is the σ -algebra of Borel subsets of \widehat{G} and $\mathcal{P}(H_{\mathbf{C}})$ is the lattice of projections of $\mathbf{B}(H_{\mathbf{C}})$. Then we have

$$\forall g \in G, \quad \rho(g) = \int_{\widehat{G}} \chi(g) \, dE_{\rho_{\mathbf{C}}}(\chi).$$

Since $\rho_{\mathbf{C}}(g) = J\rho_{\mathbf{C}}(g)J$ for every $g \in G$, we have $E_{\rho_{\mathbf{C}}}(\overline{B}) = JE_{\rho_{\mathbf{C}}}(B)J$ for every $B \in \mathcal{B}(\widehat{G})$.

We claim that there exists $\chi \in \widehat{G}$ such that $\text{supp}(E_{\rho_{\mathbf{C}}}) = \{\chi, \overline{\chi}\}$. Indeed, otherwise we can find $\chi_1, \chi_2 \in \text{supp}(E_{\rho_{\mathbf{C}}})$ such that $\{\chi_1, \overline{\chi_1}\} \cap \{\chi_2, \overline{\chi_2}\} = \emptyset$. We can then find open neighborhoods $O_1, O_2 \subset \widehat{G}$ of χ_1, χ_2 respectively such that $(O_1 \cup \overline{O_1}) \cap (O_2 \cup \overline{O_2}) = \emptyset$. Put $B = O_1 \cup \overline{O_1}$. Then $B = \overline{B}$ and $E_{\rho_{\mathbf{C}}}(B) \neq 0$. Since $O_2 \cup \overline{O_2} \subset \widehat{G} \setminus B$, we have $E_{\rho_{\mathbf{C}}}(\widehat{G} \setminus B) \neq 0$. It follows that the range K of $E_{\rho_{\mathbf{C}}}(B)$ is a subspace of $H_{\mathbf{C}}$ that is invariant under $\rho_{\mathbf{C}}(G)$ and J and such that $K \neq \{0\}$ and $K \neq H_{\mathbf{C}}$. This contradicts the irreducibility of the orthogonal representation ρ . Thus, there exists $\chi \in \widehat{G}$ such that $\text{supp}(E_{\rho_{\mathbf{C}}}) = \{\chi, \overline{\chi}\}$.

Firstly, assume that $\overline{\chi} = \chi$. Since the orthogonal representation ρ is irreducible, $E_{\rho_{\mathbf{C}}}(\{\chi\})$ is necessarily a rank one projection and so $\dim_{\mathbf{C}}(H_{\mathbf{C}}) = 1$.

This implies that $\dim_{\mathbf{R}}(H_{\mathbf{R}}) = 1$. Then there exists a continuous homomorphism $\varepsilon : G \rightarrow \{-1, 1\}$ such that for all $g \in G$, we have $\rho_g = \varepsilon_g 1_{H_{\mathbf{R}}}$.

Secondly, assume that $\bar{\chi} \neq \chi$. Since the orthogonal representation ρ is irreducible, $E_{\rho_{\mathbf{C}}}(\{\chi\})$ is necessarily a rank one projection and so $\dim_{\mathbf{C}}(H_{\mathbf{C}}) = 2$. This implies that $\dim_{\mathbf{R}}(H_{\mathbf{R}}) = 2$. Consider the one-to-one Borel map $f : \mathbf{T} \rightarrow]-\pi, \pi]$ such that $\exp(if(z)) = z$ for every $z \in \mathbf{T}$. Define the Borel map $\psi : G \rightarrow]-\pi, \pi]$ by $\psi = f \circ \chi$. Then we have $\psi(gh) - \psi(g) - \psi(h) \in 2\pi\mathbf{Z}$ for all $g, h \in G$. Moreover, there exists an orthonormal basis of $H_{\mathbf{R}}$ such that $\rho : G \curvearrowright H_{\mathbf{R}}$ has the following form:

$$\forall g \in G, \quad \rho_g = \begin{pmatrix} \cos(\psi(g)) & \sin(\psi(g)) \\ -\sin(\psi(g)) & \cos(\psi(g)) \end{pmatrix}.$$

This finishes the proof of Proposition 3.1. □

We generalize [25, Theorem 5.1] to the setting of Bogoljubov transformations of free Araki–Woods factors.

LEMMA 3.2. — *Let $U : \mathbf{R} \curvearrowright H_{\mathbf{R}}$ be any strongly continuous orthogonal representation with $\dim H_{\mathbf{R}} \geq 1$. Put $(N, \varphi) = (\Gamma(H_{\mathbf{R}}, U)'' , \varphi_U)$. Let $\pi \in \mathcal{O}(H_{\mathbf{R}})$ be any orthogonal transformation such that $[U, \pi] = 0$.*

If $\text{Ad}(\mathcal{F}(\pi)) \in \text{Inn}(N)$, then $\pi = 1$.

Proof. — Assume that $\theta = \text{Ad}(\mathcal{F}(\pi)) \in \text{Inn}(N)$. Let $u \in \mathcal{U}(N)$ such that $\theta = \text{Ad}(u)$. We show that $\pi = 1$. Since $[U, \pi] = 0$, we may define the strongly continuous orthogonal representation $\rho : \mathbf{R} \times \mathbf{Z} \curvearrowright H_{\mathbf{R}}$ by $\rho_{(t,n)} = U_t \pi^n$. There are two cases to consider.

First, assume that ρ is reducible and write $H_{\mathbf{R}} = H_{\mathbf{R}}^1 \oplus H_{\mathbf{R}}^2$ where $H_{\mathbf{R}}^i \subset H_{\mathbf{R}}$ is a nonzero ρ -invariant subspace for every $i \in \{1, 2\}$. Write $U_i = U|_{H_{\mathbf{R}}^i}$ for every $i \in \{1, 2\}$. Then [49, Theorem 2.11] implies that $(N, \varphi) = (\Gamma(H_{\mathbf{R}}^1, U_1)'' , \varphi_{U_1}) * (\Gamma(H_{\mathbf{R}}^2, U_2)'' , \varphi_{U_2})$. For every $i \in \{1, 2\}$, we moreover have

$$u \Gamma(H_{\mathbf{R}}^i, U_i)'' u^* = \theta(\Gamma(H_{\mathbf{R}}^i, U_i)'') = \Gamma(\pi(H_{\mathbf{R}}^i), U_i)'' = \Gamma(H_{\mathbf{R}}^i, U_i)''.$$

Then [57, Proposition 3.1] implies that $u \in \Gamma(H_{\mathbf{R}}^1, U_1)'' \cap \Gamma(H_{\mathbf{R}}^2, U_2)''$ and so $u \in \mathbf{T}\mathbf{1}$. Thus, $\theta = \text{id}_N$ and so $\pi = 1$.

Secondly, assume that ρ is irreducible. Since $\mathbf{R} \times \mathbf{Z}$ is an abelian lcsc group, we have $\dim(H_{\mathbf{R}}) \in \{1, 2\}$ by Proposition 3.1. If $\dim(H_{\mathbf{R}}) = 1$, we have $\theta = \text{id}_N$ and thus $\pi = 1$. If $\dim(H_{\mathbf{R}}) = 2$, there exist $0 < \lambda \leq 1$ and $\mu > 0$ and an orthonormal basis of $H_{\mathbf{R}}$ such that $\rho : \mathbf{R} \times \mathbf{Z} \curvearrowright H_{\mathbf{R}}$ has the following form:

$$\forall (t, n) \in \mathbf{R} \times \mathbf{Z}, \quad \rho_{(t,n)} = \begin{pmatrix} \cos(t \log \lambda + n \log \mu) & -\sin(t \log \lambda + n \log \mu) \\ \sin(t \log \lambda + n \log \mu) & \cos(t \log \lambda + n \log \mu) \end{pmatrix}.$$

If $\lambda = 1$, U is trivial and [25, Theorem 5.1] implies that $\pi = 1$. If $0 < \lambda < 1$, using [49, Section 4], we know that N is a type III $_\lambda$ factor. Moreover, we have $\pi = \rho_{(0,1)} = U_t$ where $t = \frac{\log \mu}{\log \lambda}$. Since $\mathbb{T}(N) = \frac{2\pi}{\log \lambda} \mathbf{Z}$ and since $\sigma_t^\varphi = \theta = \text{Ad}(u)$, there exists $k \in \mathbf{Z}$ such that $\frac{\log \mu}{\log \lambda} = t = \frac{2\pi k}{\log \lambda}$. Then $\log \mu = 2\pi k$ and so $\pi = \rho_{(0,1)} = 1$. \square

Proof of Theorem A. — Put $N = \Gamma(H_{\mathbf{R}}, U)''$ and $M = \Gamma(U, \pi)''$ so that $M = N \rtimes G$. Denote by $E_N : M \rightarrow N$ the canonical faithful normal conditional expectation. Denote by $\varphi \in N_*$ the free quasi-free state on N and put $\psi = \varphi \circ E_N \in M_*$.

(i). — We start by proving the following claim.

CLAIM 3.3. — $L(G)' \cap M = L(G)' \cap (N \rtimes \text{FC}(G))$.

Indeed, let $x \in L(G)' \cap M$ and write $x = \sum_h x^h u_h$ for its Fourier decomposition where $x^h = E_N(xu_h^*)$ for every $h \in G$. Then we have $\sigma_g^\pi(x^{g^{-1}hg}) = x^h$ for all $g, h \in G$. Since $\sigma^\pi : G \curvearrowright N$ is φ -preserving and since $\sum_h \|x^h\|_\varphi^2 = \|x\|_\psi^2 < +\infty$, it follows that $x^h = 0$ for every $h \in G \setminus \text{FC}(G)$. Since $N \rtimes \text{FC}(G) \subset M$ is σ^ψ -invariant, we may denote by $F : M \rightarrow N \rtimes \text{FC}(G)$ the unique ψ -preserving conditional expectation. Then $x = F(x) \in N \rtimes \text{FC}(G)$ and the claim is proven.

Assume that $\pi_g \neq 1$ for every $g \in \text{FC}(G) \setminus \{e\}$. Since $\mathcal{Z}(M) \subset L(G)' \cap M$, we have $\mathcal{Z}(M) = M' \cap (N \rtimes \text{FC}(G))$ by Claim 3.3. By assumption and using Lemma 3.2, the action $\sigma^\pi : \text{FC}(G) \curvearrowright N$ is outer. It follows that $N' \cap (N \rtimes \text{FC}(G)) = \mathbf{C}1$ and so $\mathcal{Z}(M) = \mathbf{C}1$.

Assume that $\pi_g = 1$ for some $g \in \text{FC}(G) \setminus \{e\}$. Then $\pi_k = 1$ for every $k \in C(g)$. This implies that $x = \sum_{k \in C(g)} u_k \in \mathcal{Z}(M)$ and so $\mathcal{Z}(M) \neq \mathbf{C}1$.

(ii). — We compute Connes' invariant $\mathbb{T}(M)$. Let $t \in \mathbf{R}$ for which there exists $g \in \mathcal{Z}(G)$ such that $U_t = \pi_g$. Then $\sigma_t^\varphi = \sigma_g^\pi$. By construction of the crossed product von Neumann algebra $M = N \rtimes G$, since $L(G) \subset M_\psi$ and since $g \in \mathcal{Z}(G)$, we have $\sigma_t^\psi = \text{Ad}(u_g)$ and so $t \in \mathbb{T}(M)$.

Conversely, let $t \in \mathbb{T}(M)$. Then there exists $u \in \mathcal{U}(M)$ such that $\sigma_t^\psi = \text{Ad}(u)$. Since $L(G) \subset M_\psi$, we have $u \in L(G)' \cap M$ and so $u \in N \rtimes \text{FC}(G)$ by Claim 3.3. As σ_t^ψ leaves N globally invariant, we have $u \in \mathcal{N}_{N \rtimes \text{FC}(G)}(N)$. By assumption and using Lemma 3.2, the action $\sigma^\pi : \text{FC}(G) \curvearrowright N$ is outer. Then there exist $v \in \mathcal{U}(N)$ and $g \in \text{FC}(G)$ such that $u = vu_g$ (see e.g. [3, Corollary 3.11]). Thus, we have $\sigma_t^\varphi = \text{Ad}(v) \circ \sigma_g^\pi$ and so $\sigma_t^\varphi \circ \sigma_{g^{-1}}^\pi \in \text{Inn}(N)$. Since $\sigma_t^\varphi \circ \sigma_{g^{-1}}^\pi = \text{Ad}(\mathcal{F}(U_t \pi_g^*))$, Lemma 3.2 implies that $U_t = \pi_g$. Since $[U, \pi] = 0$, we have $\pi_g \in \mathcal{Z}(\pi(G))$. Since M is a factor, $\pi|_{\text{FC}(G)}$ is faithful by item (i). Altogether, this implies that $g \in \mathcal{Z}(G)$.

Recall that by [49], we have $T(N) = \{t \in \mathbf{R} \mid U_t = 1\}$ and Connes' invariant $T(N)$ completely determines the type of N . In particular, we always have $T(N) \subset T(M)$.

(iii). — We now prove that Connes' invariant $T(M)$ completely determines the type of M . Denote by $c(N)$ (resp. $c(M)$) the continuous core of N (resp. M). We canonically have $c(M) = c(N) \rtimes G$ where the action $c(\sigma^\pi) : G \curvearrowright c(N)$ is given by $c(\sigma^\pi)_g(\pi_\varphi(x)\lambda_\varphi(t)) = \pi_\varphi(\sigma_g^\pi(x))\lambda_\varphi(t)$ for every $g \in G$, every $t \in \mathbf{R}$ and every $x \in N$. We prove the following claim.

CLAIM 3.4. — $L(G)' \cap c(M) = L(G)' \cap (c(N) \rtimes \text{FC}(G))$.

Indeed, let $p \in L_\varphi(\mathbf{R}) \subset c(N)$ be any nonzero finite trace projection. Since $p \in L(G)' \cap c(M)$, it follows that the restriction $c(\sigma^\pi) : G \curvearrowright p c(N) p$ is a trace preserving action on a tracial von Neumann algebra and $p c(M) p = p c(N) p \rtimes G$. The same proof as in Claim 3.3 shows that

$$\begin{aligned} p(L(G)' \cap c(M))p &= L(G)' \cap p c(M) p \\ &= L(G)' \cap (p c(N) p \rtimes \text{FC}(G)) \\ &= L(G)' \cap p(c(N) \rtimes \text{FC}(G))p \\ &= p(L(G)' \cap (c(N) \rtimes \text{FC}(G)))p. \end{aligned}$$

Since we can find an increasing sequence of nonzero finite trace projections $p_k \in L_\varphi(\mathbf{R})$ such that $p_k \rightarrow 1$ strongly, the claim is proven.

If M is of type III_1 , then $T(M) = \{0\}$ by [9, Théorème 3.4.1]. Conversely, assume that $T(M) = \{0\}$. Since $T(N) \subset T(M)$, we also have $T(N) = \{0\}$. This implies that N is of type III_1 (see [49]). By combining [16, Proposition 5.4], Lemma 3.2 and item (ii), we have that $c(\sigma^\pi) : \text{FC}(G) \curvearrowright c(N)$ is an outer action. This implies that $c(N)' \cap (c(N) \rtimes \text{FC}(G)) = \mathbf{C}1$. By Claim 3.4, we have $\mathcal{Z}(c(M)) = c(M)' \cap (c(N) \rtimes \text{FC}(G))$ and so $\mathcal{Z}(c(M)) = \mathbf{C}1$. This implies that $c(M)$ is a factor and so M is of type III_1 .

Let $0 < \lambda < 1$ and put $T = \frac{2\pi}{\log \lambda}$. If M is of type III_λ , then $T(M) = T\mathbf{Z}$ by [9, Théorème 3.4.1]. Conversely, assume that $T(M) = T\mathbf{Z}$. Since $T(N) \subset T(M)$, we have $T(N) = \kappa T\mathbf{Z}$ for some $\kappa \in \mathbf{N}$. Since M is a factor, $\pi|_{\text{FC}(G)}$ is faithful and we may denote by $g \in \mathcal{Z}(G)$ the unique element such that $U_T = \pi_g$. Moreover, the map $\varepsilon : T(M) \rightarrow \mathcal{Z}(G) : kT \mapsto g^k$ is a well-defined group homomorphism.

Firstly, assume that $\kappa = 0$, so that N is of type III_1 (see [49]). Since $c(N)$ is a factor and since $c(\sigma^\pi)_h$ is outer for every $h \in \text{FC}(G) \setminus g^{\mathbf{Z}}$ (by combining [16, Proposition 5.4], Lemma 3.2 and item (ii)), it follows that

$$c(N)' \cap ((c(N) \rtimes \text{FC}(G))) = c(N)' \cap (c(N) \rtimes g^{\mathbf{Z}}).$$

Using the above observation with Claim 3.4, we infer that

$$\begin{aligned} \mathcal{Z}(c(M)) &= L(G)' \cap (c(N)' \cap (c(N) \rtimes \text{FC}(G))) \\ &= L(G)' \cap (c(N)' \cap (c(N) \rtimes g^{\mathbf{Z}})) \\ &= L(G)' \cap \{u_g^* \lambda_\varphi(T)\}'' \quad (\text{since } c(N) \text{ is a factor}) \\ &= \{u_g^* \lambda_\varphi(T)\}'' = L^\infty(\mathbf{R}/T\mathbf{Z}). \end{aligned}$$

Since the action $\mathbf{R} \curvearrowright \mathbf{R}/T\mathbf{Z}$ is essentially transitive, the dual action $\mathbf{R} \curvearrowright \mathcal{Z}(c(M))$ is essentially transitive and so M is of type III_λ .

Secondly, assume that $\kappa \geq 1$. We have $1 = U_{\kappa T} = \pi_{g^\kappa}$. Since $\pi|_{\text{FC}(G)}$ is faithful, we have $g^\kappa = 1$ and so have $g^{\mathbf{Z}} \cong \mathbf{Z}/\kappa\mathbf{Z}$. Since $T(N) = \kappa T\mathbf{Z} = \frac{2\pi}{\log \lambda^{1/\kappa}} \mathbf{Z}$, N is of type $\text{III}_{\lambda^{1/\kappa}}$ (see [49]). Then φ is κT -periodic and we have $(N_\varphi)' \cap N = \mathbf{C}1$ by [9, Théorème 4.2.6]. Observe that $M_\psi = N_\varphi \rtimes G$. We next prove the following claim.

CLAIM 3.5. — $\mathcal{Z}(M_\psi) = L(g^{\mathbf{Z}})$.

Indeed, by Claim 3.3, we have

$$\mathcal{Z}(M_\psi) = (N_\varphi)' \cap L(G)' \cap (N_\varphi \rtimes G) = (N_\varphi)' \cap L(G)' \cap (N_\varphi \rtimes \text{FC}(G)).$$

Let $x \in (N_\varphi)' \cap (N_\varphi \rtimes \text{FC}(G))$ and write $x = \sum_h x^h u_h$ for its Fourier decomposition. Then we have $yx^h = x^h \sigma_h^\pi(y)$ for every $h \in \text{FC}(G)$ and every $y \in N_\varphi$. Since $(N_\varphi)' \cap N = \mathbf{C}1$, for every $h \in \text{FC}(G)$, there exist $\alpha_h \in \mathbf{C}$ and $v_h \in \mathcal{U}(N_\varphi)$ so that $x^h = \alpha_h v_h$. Let $h \in \text{FC}(G)$ such that $\alpha_h \neq 0$. Then $\sigma_h^\pi|_{N_\varphi} = \text{Ad}(v_h)|_{N_\varphi}$. Then $\text{Ad}(v_h^*) \circ \sigma_h^\pi$ is φ -preserving and $\text{Ad}(v_h^*) \circ \sigma_h^\pi|_{N_\varphi} = \text{id}_{N_\varphi}$. Applying the proof of [16, Theorem 3.2] to the periodic weight $\varphi \otimes \text{Tr}_{\mathbf{B}(\ell_2)}$, there exists $t \in \mathbf{R}$ such that $\text{Ad}(v_h^*) \circ \sigma_h^\pi = \sigma_t^\varphi$. Lemma 3.2 implies that $U_t = \pi_h$ and so $t \in T(M)$ and $h \in g^{\mathbf{Z}}$. This shows that $(N_\varphi)' \cap (N_\varphi \rtimes \text{FC}(G)) = (N_\varphi)' \cap (N_\varphi \rtimes g^{\mathbf{Z}}) = L(g^{\mathbf{Z}})$ (since N_φ is a factor) and so $\mathcal{Z}(M_\psi) = L(g^{\mathbf{Z}})$.

Since $\mathcal{Z}(M_\psi)$ is discrete, M cannot be of type III_0 (see [9, Cor. 3.2.7(b)]) and so M is of type III_λ by [9, Théorème 3.4.1].

If M is of type II_1 , then $T(M) = \mathbf{R}$. Conversely, if $T(M) = \mathbf{R}$, since M has separable predual, it follows that M is semifinite by [9, Théorème 1.3.4(b)]. Since $N \subset M$ is with expectation, this further implies that N is semifinite (see [54, Lemma V.2.29]) and so N is a type II_1 factor by [49]. Since the free Bogoljubov action $G \curvearrowright (N, \tau)$ is trace-preserving, $M = N \rtimes G$ is a type II_1 factor.

Using the above reasoning, M is of type III_0 if and only if $T(M)$ is dense in \mathbf{R} and $T(M) \neq \mathbf{R}$. Therefore, Connes' invariant $T(M)$ completely determines the type of M .

(iv). — Finally, assume that M is a type III₁ factor. For bicentralizer algebras, we use notation of [20, Section 3]. To prove that M has trivial bicentralizer, it suffices to show that $B(M, \psi) = \mathbf{C}1$. Using item (ii), $Q = N \rtimes \text{FC}(G)$ is a type III₁ factor. Choose a nonprincipal ultrafilter $\omega \in \beta(\mathbf{N}) \setminus \mathbf{N}$. Using [20, Proposition 3.2] and Claim 3.3, we have

$$\begin{aligned} B(M, \psi) &= ((M^\omega)_{\psi^\omega})' \cap M \subset ((Q^\omega)_{\psi^\omega})' \cap L(G)' \cap M \subset ((Q^\omega)_{\psi^\omega})' \cap Q \\ &= B(Q, \psi). \end{aligned}$$

In order to prove that $B(M, \psi) = \mathbf{C}1$, it suffices to show that $B(Q, \psi) = \mathbf{C}1$.

Put $H = \text{FC}(G)$. Fix an enumeration $\{h_n \mid n \in \mathbf{N}\}$ of H . For every $n \in \mathbf{N}$, denote by H_n the subgroup of H generated by $\{h_0, \dots, h_n\}$. Then $(H_n)_n$ is an increasing sequence of subgroups of H such that $\bigcup_{n \in \mathbf{N}} H_n = H$. For every $n \in \mathbf{N}$, since H_n is finitely generated and since $\text{FC}(H_n) = H_n$, its center $\mathcal{Z}(H_n)$ has finite index in H_n and so H_n is virtually abelian. Using item (ii), $Q_n = N \rtimes H_n$ is a type III₁ factor. Theorem 6.1 implies that Q_n is semisolid and [20, Theorem 3.7] implies that Q_n has trivial bicentralizer. Thus, we have $B(Q_n, \psi) = \mathbf{C}1$ for every $n \in \mathbf{N}$.

For every $n \in \mathbf{N}$, denote by $E_{Q_n} : Q \rightarrow Q_n$ the unique ψ -preserving conditional expectation. Let $x \in B(Q, \psi)$. Then $E_{Q_n}(x) \in B(Q_n, \psi)$ and so $E_{Q_n}(x) = \psi(x)1$. Since $\lim_n \|x - E_{Q_n}(x)\|_\psi = 0$, it follows that $x = \psi(x)1$. Thus, we have $B(Q, \psi) = \mathbf{C}1$ and so $B(M, \psi) = \mathbf{C}1$. This finishes the proof of Theorem A. □

4. Fullness

We fix the following notation. Let $U : \mathbf{R} \curvearrowright H_{\mathbf{R}}$ be any strongly continuous orthogonal representation with $\dim H_{\mathbf{R}} \geq 2$. Let G be any countable group and $\pi : G \curvearrowright H_{\mathbf{R}}$ any faithful orthogonal representation such that $[U, \pi] = 0$. Put $M = \Gamma(U, \pi)''$ and denote by $(M, L^2(M), J, L^2(M)_+)$ its standard form. Write $\varphi \in M_*$ for the canonical faithful state on M .

Write $H_{\mathbf{R}} = H_{\mathbf{R}}^{\text{ap}} \oplus H_{\mathbf{R}}^{\text{wm}}$ where $H_{\mathbf{R}}^{\text{ap}}$ (resp. $H_{\mathbf{R}}^{\text{wm}}$) is the *almost periodic* (resp. *weakly mixing*) part of the orthogonal representation $\pi : G \curvearrowright H_{\mathbf{R}}$. Note that the subspace $H_{\mathbf{R}}^{\text{wm}}$ is invariant under U (and so is $H_{\mathbf{R}}^{\text{ap}}$). Likewise, write $H = H^{\text{ap}} \oplus H^{\text{wm}}$ where H^{ap} (resp. H^{wm}) is the almost periodic (resp. weakly mixing) part of the corresponding unitary representation $\pi : G \curvearrowright H$. As usual, denote by A the infinitesimal generator of $U : \mathbf{R} \curvearrowright H$ and let $j : H_{\mathbf{R}} \rightarrow H : \eta \mapsto (\frac{2}{A^{-1}+1})^{1/2}\eta$ be the corresponding isometric embedding. Put $K_{\mathbf{R}} = j(H_{\mathbf{R}})$, $K_{\mathbf{R}}^{\text{ap}} = j(H_{\mathbf{R}}^{\text{ap}})$ and $K_{\mathbf{R}}^{\text{wm}} = j(H_{\mathbf{R}}^{\text{wm}})$. Recall

that $K_{\mathbf{R}} \cap iK_{\mathbf{R}} = \{0\}$ and $K_{\mathbf{R}} + iK_{\mathbf{R}}$ is dense in H . We consider the involution $K_{\mathbf{R}} + iK_{\mathbf{R}} \rightarrow K_{\mathbf{R}} + iK_{\mathbf{R}}$ given $\overline{\xi + i\eta} = \xi - i\eta$ for all $\xi, \eta \in K_{\mathbf{R}}$.

Let $L \subset K_{\mathbf{R}} + iK_{\mathbf{R}}$ be any subspace such that $\overline{L} = L$. Denote by $\mathcal{X}(L)$ the closure in $L^2(M)$ of the linear span of all the elements of the form $e_1 \otimes \cdots \otimes e_k \otimes \delta_h$ where $k \geq 1$, $e_1 \in L$, $e_2, \dots, e_k \in K_{\mathbf{R}} + iK_{\mathbf{R}}$, $h \in G$.

LEMMA 4.1. — Assume that $H_{\mathbf{R}}^{\text{wm}} \neq 0$. Let $L \subset K_{\mathbf{R}}^{\text{wm}} + iK_{\mathbf{R}}^{\text{wm}}$ be any nonzero finite dimensional subspace. Then for every $x = (x_n)^\omega \in L(G)' \cap M^\omega$, we have $\lim_{n \rightarrow \omega} \|P_{\mathcal{X}(L)}(x_n \xi_\varphi)\| = 0$.

Proof. — Fix an integer $N \geq 1$. Since the representation $\pi|_{H^{\text{wm}}}$ is weakly mixing and since $L \subset K_{\mathbf{R}}^{\text{wm}} + iK_{\mathbf{R}}^{\text{wm}} \subset H^{\text{wm}}$ is finite dimensional, we may choose inductively elements $g_1, \dots, g_N \in G$ such that $\pi_{g_i}(L) \perp_{1/(N \dim(L))} \pi_{g_j}(L)$ for all $1 \leq i < j \leq N$. We start by proving the following claim.

CLAIM 4.2. — For all $1 \leq i < j \leq N$, we have $\mathcal{X}(\pi_{g_i}(L)) \perp_{1/N} \mathcal{X}(\pi_{g_j}(L))$.

Indeed, let $1 \leq i < j \leq N$ and put $g = g_j^{-1}g_i \in G$. Put $U_g = u_g J u_g J \in \mathcal{U}(L^2(M))$. We have $U_g(\mathcal{X}(L)) = \mathcal{X}(\pi_g(L))$. Let $(l_a)_{1 \leq a \leq \dim(L)}$ be an orthonormal basis for the space L . Let $\xi, \eta \in \mathcal{X}(L)$ be any elements. Observe that we may and will identify $L^2(M) \ominus L^2(L(G))$ with $H \otimes L^2(M)$ via the unitary operator

$$U : L^2(M) \ominus L^2(L(G)) \rightarrow H \otimes L^2(M) \\ \zeta_1 \otimes \cdots \otimes \zeta_\ell \otimes \delta_g \mapsto \zeta_1 \otimes (\zeta_2 \otimes \cdots \otimes \zeta_\ell \otimes \delta_g)$$

where $\ell \geq 1$, $\zeta_1, \dots, \zeta_\ell \in H$, $g \in G$. We can then write $\xi = \sum_{a=1}^{\dim(L)} l_a \otimes \xi_a$ and $\eta = \sum_{b=1}^{\dim(L)} l_b \otimes \eta_b$ for some $\xi_a, \eta_b \in L^2(M)$. Using Cauchy-Schwarz inequality and the assumption that $\pi_g(L) \perp_{(1/N \dim(L))} L$, we have

$$|\langle U_g(\xi), \eta \rangle| \leq \sum_{a,b=1}^{\dim(L)} |\langle \pi_g(l_a), l_b \rangle| |\langle U_g(\xi_a), \eta_b \rangle| \\ \leq \frac{1}{N \dim(L)} \sum_{a,b=1}^{\dim(L)} \|\xi_a\| \|\eta_b\| \\ \leq \frac{1}{N} \|\xi\| \|\eta\|.$$

This proves that $\mathcal{X}(\pi_g(L)) \perp_{1/N} \mathcal{X}(L)$ and so $\mathcal{X}(\pi_{g_i}(L)) \perp_{1/N} \mathcal{X}(\pi_{g_j}(L))$.

For all $g \in G$ and all $n \in \mathbf{N}$, we have

$$\begin{aligned} \|P_{\mathcal{X}(L)}(x_n \xi_\varphi)\|^2 &= \langle P_{\mathcal{X}(L)}(x_n \xi_\varphi), x_n \xi_\varphi \rangle \\ &= \langle U_g(P_{\mathcal{X}(L)}(x_n \xi_\varphi)), U_g(x_n \xi_\varphi) \rangle \\ &= \langle P_{\mathcal{X}(\pi_g(L))}(U_g(x_n \xi_\varphi)), U_g(x_n \xi_\varphi) \rangle \end{aligned}$$

Since $u_g \in L(G) \subset M_\varphi$, we have $U_g(x_n \xi_\varphi) = u_g x_n u_g^* \xi_\varphi$. Since $x = (x_n)^\omega \in L(G)' \cap M^\omega$, we have $\lim_{n \rightarrow \omega} \|(u_g x_n u_g^* - x_n) \xi_\varphi\| = 0$ and so

$$\lim_{n \rightarrow \omega} \|P_{\mathcal{X}(L)}(x_n \xi_\varphi)\|^2 = \lim_{n \rightarrow \omega} \langle P_{\mathcal{X}(\pi_g(L))}(x_n \xi_\varphi), x_n \xi_\varphi \rangle.$$

Applying the above result to $g_1, \dots, g_N \in G$, we obtain, using Cauchy–Schwarz inequality,

$$\begin{aligned} \lim_{n \rightarrow \omega} \|P_{\mathcal{X}(L)}(x_n \xi_\varphi)\|^2 &= \lim_{n \rightarrow \omega} \frac{1}{N} \sum_{i=1}^N \langle P_{\mathcal{X}(\pi_{g_i}(L))}(x_n \xi_\varphi), x_n \xi_\varphi \rangle \\ &= \lim_{n \rightarrow \omega} \frac{1}{N} \left\langle \sum_{i=1}^N P_{\mathcal{X}(\pi_{g_i}(L))}(x_n \xi_\varphi), x_n \xi_\varphi \right\rangle \\ &\leq \lim_{n \rightarrow \omega} \frac{1}{N} \left\| \sum_{i=1}^N P_{\mathcal{X}(\pi_{g_i}(L))}(x_n \xi_\varphi) \right\| \|x_n\|_\varphi. \end{aligned}$$

Using Claim 4.2, for all $n \in \mathbf{N}$, we have

$$\begin{aligned} \left\| \sum_{i=1}^N P_{\mathcal{X}(\pi_{g_i}(L))}(x_n \xi_\varphi) \right\|^2 &= \sum_{1 \leq i, j \leq N} \langle P_{\mathcal{X}(\pi_{g_i}(L))}(x_n \xi_\varphi), P_{\mathcal{X}(\pi_{g_j}(L))}(x_n \xi_\varphi) \rangle \\ &\leq \sum_{i=1}^N \|P_{\mathcal{X}(\pi_{g_i}(L))}(x_n \xi_\varphi)\|^2 + \frac{1}{N} \sum_{1 \leq i \neq j \leq N} \|x_n\|_\varphi^2 \\ &\leq N \|x_n\|_\varphi^2 + \frac{N(N-1)}{N} \|x_n\|_\varphi^2 = (2N-1) \|x_n\|_\varphi^2. \end{aligned}$$

In the end, we obtain $\lim_{n \rightarrow \omega} \|P_{\mathcal{X}(L)}(x_n \xi_\varphi)\|^2 \leq \frac{\sqrt{2N-1}}{N} \|x\|_\varphi^2$. Since this is true for every $N \geq 1$, we obtain that $\lim_{n \rightarrow \omega} \|P_{\mathcal{X}(L)}(x_n \xi_\varphi)\| = 0$. \square

Following [20, Appendix C], define $K_{\text{an}}^{\text{wm}} = \bigcup_{\lambda > 0} \mathbf{1}_{[\lambda^{-1}, \lambda]}(A)(H^{\text{wm}}) \subset K_{\mathbf{R}}^{\text{wm}} + iK_{\mathbf{R}}^{\text{wm}}$. Observe that $\overline{K_{\text{an}}^{\text{wm}}} = K_{\text{an}}^{\text{wm}}$ and that $K_{\text{an}}^{\text{wm}} \subset K_{\mathbf{R}}^{\text{wm}} + iK_{\mathbf{R}}^{\text{wm}}$ is a dense subspace in H^{wm} of elements $\eta \in K_{\mathbf{R}}^{\text{wm}} + iK_{\mathbf{R}}^{\text{wm}}$ for which the map $\mathbf{R} \mapsto K_{\mathbf{R}}^{\text{wm}} + iK_{\mathbf{R}}^{\text{wm}} : t \mapsto U_t \eta$ extends to a $(K_{\mathbf{R}}^{\text{wm}} + iK_{\mathbf{R}}^{\text{wm}})$ -valued entire analytic map. For all $\eta \in K_{\text{an}}^{\text{wm}}$, the element $W(\eta)$ is entire analytic for the modular automorphism group σ^φ and we have $\sigma_z^\varphi(W(\eta)) = W(A^{iz} \eta)$ for every $z \in \mathbf{C}$.

LEMMA 4.3. — Assume that $H_{\mathbf{R}}^{\text{wm}} \neq 0$. Let $x = (x_n)^\omega \in L(G)' \cap M^\omega$, $\xi \in K_{\text{an}}^{\text{wm}}$ any unit vector and $(t_n)_{n \in \mathbf{N}}$ any real-valued sequence such that

$$\lim_{n \rightarrow \omega} \|x_n W(U_{t_n} \xi) - W(\xi) x_n\|_\varphi = 0.$$

Then we have $x \in L(G)^\omega$.

Proof. — Observe that for every $t \in \mathbf{R}$, we have $\sigma_{-i/2}^\varphi(W(U_t \xi)^*) = \sigma_{-i/2}^\varphi(W(U_t \bar{\xi})) = W(A^{1/2+it} \bar{\xi})$. For every $n \in \mathbf{N}$, put $y_n = x_n - E_{L(G)}(x_n) \in M \ominus L(G)$. Put $y = x - E_{L(G)^\omega}(x) \in M^\omega \ominus L(G)^\omega$ so that $y = (y_n)^\omega$. For all $n \in \mathbf{N}$, we have

$$\begin{aligned} (4.1) \quad & (x_n W(U_{t_n} \xi) - W(\xi) x_n) \xi_\varphi \\ &= (y_n W(U_{t_n} \xi) - W(\xi) y_n) \xi_\varphi \\ &\quad + (E_{L(G)}(x_n) W(U_{t_n} \xi) - W(\xi) E_{L(G)}(x_n)) \xi_\varphi \\ &= JW(A^{1/2+it_n} \bar{\xi}) J y_n \xi_\varphi - W(\xi) y_n \xi_\varphi \\ &\quad + E_{L(G)}(x_n) W(U_{t_n} \xi) \xi_\varphi - W(\xi) E_{L(G)}(x_n) \xi_\varphi. \end{aligned}$$

Put $L = \text{span}\{\xi, \bar{\xi}\} \subset K_{\mathbf{R}}^{\text{wm}} + iK_{\mathbf{R}}^{\text{wm}}$. Lemma 4.1 implies that

$$\lim_{n \rightarrow \omega} \|y_n \xi_\varphi - P_{\mathcal{X}(L^\perp)}(y_n \xi_\varphi)\|_2 = 0.$$

Since $(JW(A^{1/2+it_n} \bar{\xi}) J)_n$ is uniformly bounded, in the ultraproduct Hilbert space $L^2(M)^\omega$, we have the following equalities

$$(4.2) \quad \begin{aligned} & (W(\xi) y_n \xi_\varphi)_\omega = (W(\xi) P_{\mathcal{X}(L^\perp)}(y_n \xi_\varphi))_\omega \\ & (JW(A^{1/2+it_n} \bar{\xi}) J y_n \xi_\varphi)_\omega = (JW(A^{1/2+it_n} \bar{\xi}) J P_{\mathcal{X}(L^\perp)}(y_n \xi_\varphi))_\omega. \end{aligned}$$

Using the Wick formula, for every $n \in \mathbf{N}$, we have that

- $W(\xi) P_{\mathcal{X}(L^\perp)}(y_n \xi_\varphi)$ lies in the closure in $L^2(M)$ of the linear span of all the elements of the form $\xi \otimes \eta \otimes e_1 \otimes \dots \otimes e_k \otimes \delta_h$ where $k \geq 0$, $\eta \in L^\perp$, $e_1, \dots, e_k \in K_{\mathbf{R}} + iK_{\mathbf{R}}$, $h \in G$.
- $JW(A^{1/2+it_n} \bar{\xi}) J P_{\mathcal{X}(L^\perp)}(y_n \xi_\varphi)$ lies in the closure in $L^2(M)$ of the linear span of all the elements of the form δ_h or $\eta \otimes e_1 \otimes \dots \otimes e_k \otimes \delta_h$ where $k \geq 0$, $\eta \in L^\perp$, $e_1, \dots, e_k \in K_{\mathbf{R}} + iK_{\mathbf{R}}$, $h \in G$.
- $E_{L(G)}(x_n) W(U_{t_n} \xi) \xi_\varphi - W(\xi) E_{L(G)}(x_n) \xi_\varphi$ lies in the closure in $L^2(M)$ of the linear span of all the elements of the form δ_h or $e \otimes \delta_h$ where $e \in K_{\mathbf{R}} + iK_{\mathbf{R}}$, $h \in G$.

This implies that $W(\xi) P_{\mathcal{X}(L^\perp)}(y_n \xi_\varphi)$ is orthogonal to $JW(A^{1/2+it_n} \bar{\xi}) \times J P_{\mathcal{X}(L^\perp)}(y_n \xi_\varphi)$ and to $E_{L(G)}(x_n) W(U_{t_n} \xi) \xi_\varphi - W(\xi) E_{L(G)}(x_n) \xi_\varphi$ for every $n \in \mathbf{N}$. Using moreover the assumption together with (4.1) and (4.2), we obtain $\lim_{n \rightarrow \omega} \|W(\xi) P_{\mathcal{X}(L^\perp)}(y_n \xi_\varphi)\| = 0$. Since for every

$n \in \mathbf{N}$, we have $W(\xi)P_{\mathcal{X}(L^\perp)}(y_n\xi_\varphi) = \xi \otimes P_{\mathcal{X}(L^\perp)}(y_n\xi_\varphi)$, it follows that $\lim_{n \rightarrow \omega} \|P_{\mathcal{X}(L^\perp)}(y_n\xi_\varphi)\| = 0$ and so $\lim_{n \rightarrow \omega} \|y_n\xi_\varphi\| = 0$. This shows that $x - E_{L(G)^\omega}(x) = y = 0$ and so $x = E_{L(G)^\omega}(x) \in L(G)^\omega$. \square

Proof of Theorem B. — Put $M = \Gamma(U, \pi)'' = N \rtimes G$.

(i). — We first consider the case when G is finite. In that case, the image of $\sigma^\pi(G)$ in $\text{Out}(N)$ is finite thus discrete. Then [36, Theorem B] implies that $M = N \rtimes G$ is a full factor.

We next consider the case when G is infinite. Since $\pi(G) \subset \mathcal{O}(H_{\mathbf{R}})$ is infinite (π is faithful) and discrete with respect to the strong topology, it follows that the weakly mixing part of π is nonzero, that is, $H_{\mathbf{R}}^{\text{wm}} \neq 0$. We may then choose a unit vector $\xi \in K_{\text{an}}^{\text{wm}}$.

Let $x = (x_n)^\omega \in M' \cap M^\omega$ be any element. Since $x = (x_n)^\omega \in L(G)' \cap M^\omega$ and since $\lim_{n \rightarrow \omega} \|x_n W(\xi) - W(\xi)x_n\|_\varphi = 0$, Lemma 4.3 implies that $x \in L(G)^\omega$. We may then replace each x_n by $E_{L(G)}(x_n)$ and assume that $x = (x_n)^\omega$ where $x_n \in L(G)$. Since $\pi(G) \subset \mathcal{O}(H_{\mathbf{R}})$ is discrete with respect to the strong topology, $\sigma^\pi(G) \subset \text{Aut}(M)$ is discrete with respect to the u -topology. Since π is faithful and since σ^π is φ -preserving, there exist $\kappa > 0$ and $y_1, \dots, y_m \in N$ such that for all $g \in G \setminus \{0\}$, we have

$$\sum_{k=1}^m \|\sigma_g^\pi(y_k) - y_k\|_\varphi^2 \geq \kappa.$$

Write $x_n = \sum_{g \in G} (x_n)^g u_g$ for the Fourier decomposition of x_n in $L(G)$. We have

$$\begin{aligned} \sum_{k=1}^m \|x_n y_k - y_k x_n\|_\varphi^2 &= \sum_{g \in G} |(x_n)^g|^2 \sum_{k=1}^m \|\sigma_g^\pi(y_k) - y_k\|_\varphi^2 \\ &\geq \kappa \sum_{g \in G \setminus \{e\}} |(x_n)^g|^2 \\ &= \kappa \|x_n - \tau(x_n)1\|_2^2. \end{aligned}$$

Since $x \in M' \cap L(G)^\omega$, we have $\lim_{n \rightarrow \omega} \|x_n y_k - y_k x_n\|_\varphi = 0$ for all $1 \leq k \leq m$. This implies that $\lim_{n \rightarrow \omega} \|x_n - \tau(x_n)1\|_2 = 0$ and so $x \in \mathbf{C}1$. This shows that M is full.

(ii). — Assume that $(t_n)_{n \in \mathbf{N}}$ is a sequence converging to 0 with respect to $\tau(M)$. By definition, it means that the class of $\sigma_{t_n}^\varphi$ converges to 1 in $\text{Out}(M)$. Therefore, there exists a sequence of unitaries $u_n \in \mathcal{U}(M)$ such that $\text{Ad}(u_n) \circ \sigma_{t_n}^\varphi \rightarrow \text{id}_M$ with respect to the u -topology in $\text{Aut}(M)$. Since $\text{Aut}(M)$ is a topological group, $\sigma_{-t_n}^\varphi \circ \text{Ad}(u_n^*) = (\text{Ad}(u_n) \circ \sigma_{t_n}^\varphi)^{-1} \rightarrow \text{id}_M$ with respect to the u -topology in $\text{Aut}(M)$. This implies that $\lim_n \|u_n \varphi -$

$\varphi u_n\| = 0$. Let $\omega \in \beta(\mathbf{N}) \setminus \mathbf{N}$ be any nonprincipal ultrafilter. We have $(u_n)_n \in \mathfrak{M}^\omega(M)$ and $(u_n)^\omega \in (M^\omega)_{\varphi^\omega}$.

For every $g \in G$, we have $\lim_{n \rightarrow \omega} \|u_n \sigma_{t_n}^\varphi(u_g) - u_g u_n\|_\varphi = 0$. Since $\sigma_{t_n}^\varphi(u_g) = u_g$, we obtain that $(u_n)^\omega \in L(G)' \cap M^\omega$. We also have $\lim_{n \rightarrow \omega} \|u_n W(U_{t_n} \xi) - W(\xi) u_n\|_\varphi = \lim_{n \rightarrow \omega} \|u_n \sigma_{t_n}^\varphi(W(\xi)) - W(\xi) u_n\|_\varphi = 0$. Lemma 4.3 implies that $(u_n)^\omega \in L(G)^\omega$. Since $u = (u_n)^\omega \in L(G)^\omega$, we may choose unitaries $v_n \in \mathcal{U}(L(G))$ such that $u = (v_n)^\omega$. We then have $\text{Ad}(v_n^* u_n) \rightarrow \text{id}_M$ as $n \rightarrow \omega$ and so $\text{Ad}(v_n) \circ \sigma_{t_n}^\varphi \rightarrow \text{id}_M$ as $n \rightarrow \omega$ with respect to the u -topology in $\text{Aut}(M)$.

Write $v_n = \sum_{g \in G} (v_n)^g u_g$ for the Fourier decomposition of v_n in $L(G)$. We claim that

$$(4.3) \quad \exists \kappa > 0, \exists y_1, \dots, y_m \in N, \forall g \in G \setminus \{e\}, \forall t \in \mathbf{R},$$

$$\sum_{k=1}^m \|(\sigma_g^\pi \circ \sigma_t^\varphi)(y_k) - (y_k)\|_\varphi^2 \geq \kappa.$$

Indeed, if (4.3) does not hold, then there exist $g_i \in G \setminus \{e\}$ and $t_i \in \mathbf{R}$ such that $\sigma_{g_i}^\pi \circ \sigma_{t_i}^\varphi \rightarrow \text{id}_N$ with respect to the u -topology in $\text{Aut}(N)$. This implies that $\rho_{(t_i, g_i)} = U_{t_i} \pi_{g_i} \rightarrow 1$ strongly, contradicting the assumption on ρ . Then (4.3) holds. For every $n \in \mathbf{N}$, we have

$$\begin{aligned} \sum_{k=1}^m \|v_n \sigma_{t_n}^\varphi(y_k) - y_k v_n\|_\varphi^2 &= \sum_{g \in G} |(v_n)^g|^2 \sum_{k=1}^m \|(\sigma_g^\pi \circ \sigma_{t_n}^\varphi)(y_k) - y_k\|_\varphi^2 \\ &\geq \kappa \sum_{g \in G \setminus \{e\}} |(v_n)^g|^2 \\ &= \kappa \|v_n - \tau(v_n)1\|_2^2. \end{aligned}$$

Since $\text{Ad}(v_n) \circ \sigma_{t_n}^\varphi \rightarrow \text{id}_M$ as $n \rightarrow \omega$ with respect to the u -topology in $\text{Aut}(M)$, we have $\lim_{n \rightarrow \omega} \|v_n \sigma_{t_n}^\varphi(y_k) - y_k v_n\|_\varphi = 0$ for all $1 \leq k \leq m$. This implies that $\lim_{n \rightarrow \omega} \|v_n - \tau(v_n)1\|_2 = 0$ and so $\lim_{n \rightarrow \omega} \|u_n - \varphi(u_n)1\|_\varphi = 0$. Since this is true for every nonprincipal ultrafilter $\omega \in \beta(\mathbf{N}) \setminus \mathbf{N}$, we have $\lim_n \|u_n - \varphi(u_n)1\|_\varphi = 0$ and so $\text{Ad}(u_n) \rightarrow \text{id}_M$ with respect to the u -topology in $\text{Aut}(M)$. Therefore $\sigma_{t_n}^\varphi \rightarrow \text{id}$ with respect to the u -topology in $\text{Aut}(M)$. This further implies that $U_{t_n} \rightarrow 1$ strongly which means that $t_n \rightarrow 0$ with respect to $\tau(U)$. \square

5. Amenable and Gamma absorption

Before proving Theorem C, we state a type III version of Krogager–Vaes’ result [34, Theorem 5.1(2)].

THEOREM 5.1. — *Let $U : \mathbf{R} \curvearrowright H_{\mathbf{R}}$ be any strongly continuous orthogonal representation. Let G be any countable group and $\pi : G \curvearrowright H_{\mathbf{R}}$ any orthogonal representation such that $[U, \pi] = 0$. Put $M = \Gamma(U, \pi)''$.*

- (i) *Assume that $\pi : G \curvearrowright H_{\mathbf{R}}$ is weakly mixing. Let $L(G) \subset P \subset M$ be any intermediate von Neumann subalgebra with expectation such that $P \triangleleft_M L(G)$. Then $P = L(G)$.*
- (ii) *Assume that $\pi : G \curvearrowright H_{\mathbf{R}}$ is mixing. Let $P \subset M$ be any von Neumann subalgebra with expectation such that $P \triangleleft_M L(G)$ and $P \cap L(G)$ is diffuse. Then $P \subset L(G)$.*

Proof.

(i). — We adapt the proof of [34, Theorem 5.1 (2)] for the reader’s convenience. Put $M = \Gamma(U, \pi)''$ and denote by φ the canonical faithful normal state on M . Since $P \triangleleft_M L(G)$, there exists a norm one projection $\Phi : \langle M, L(G) \rangle \rightarrow P$ such that $\Phi|_M : M \rightarrow P$ is the unique φ -preserving conditional expectation. Actually there exists a unique faithful normal conditional expectation $E_P : M \rightarrow P$. Indeed, since π is weakly mixing, the φ -preserving action $G \curvearrowright (N, \varphi)$ is φ -weakly mixing. Theorem A.5 (i) implies that $P' \cap M \subset L(G)' \cap M \subset L(G) \subset P$. Then [9, Théorème 1.5.5] implies that there exists a unique faithful normal conditional expectation $E_P : M \rightarrow P$.

As usual, denote by A the infinitesimal generator of the strongly continuous unitary representation $U : \mathbf{R} \curvearrowright H$. Put $K_{\mathbf{R}} = j(H_{\mathbf{R}})$ where $j : H_{\mathbf{R}} \rightarrow H : \xi \mapsto (\frac{2}{A-1+i})^{1/2}\xi$ is the canonical isometric embedding. Recall that $K_{\mathbf{R}} \cap iK_{\mathbf{R}} = \{0\}$ and $K_{\mathbf{R}} + iK_{\mathbf{R}}$ is dense in H .

Denote by $(M, L^2(M), J, L^2(M)_+)$ the standard form of M . We identify $L^2(M) = \mathcal{F}(H) \otimes \ell^2(G)$ and we view $M = N \rtimes G \subset \mathbf{B}(\mathcal{F}(H) \otimes \ell^2(G))$ as generated by $b \otimes 1$ for $b \in N$ and by $u_g = \mathcal{F}(\pi_g) \otimes \lambda_g$ for $g \in G$. For every $g \in G$, we have $Ju_gJ = 1 \otimes \rho_g$. For every $T \in \mathbf{B}(\mathcal{F}(H))$, we identify T with $T \otimes 1 \in \mathbf{B}(\mathcal{F}(H) \otimes \ell^2(G))$. In particular, for every $T \in \mathbf{B}(\mathcal{F}(H))$, we have $T \in (JL(G)J)' \cap \mathbf{B}(L^2(M)) = \langle M, L(G) \rangle$.

For every unit vector $e \in K_{\mathbf{R}}$, denote by $P_e = \ell(e)\ell(e)^*$ the orthogonal projection $L^2(M) \rightarrow \mathcal{X}(\mathbf{C}e)$ where $\mathcal{X}(\mathbf{C}e)$ is the closure in $L^2(M)$ of the linear span of all the elements of the form $e \otimes e_1 \cdots \otimes e_k \otimes \delta_h$ where $k \geq 0$, $e_1, \dots, e_k \in K_{\mathbf{R}} + iK_{\mathbf{R}}$, $h \in G$.

CLAIM 5.2. — *For every unit vector $e \in K_{\mathbf{R}}$, we have $\Phi(P_e) = 0$.*

Indeed, fix an integer $N \geq 1$. Since π is weakly mixing, we may choose inductively elements $g_1, \dots, g_N \in G$ such that $|\langle \pi_{g_i}(e), \pi_{g_j}(e) \rangle| \leq 1/N$ for all $1 \leq i < j \leq N$. Claim 4.2 implies that $\mathcal{X}(\mathbf{C}\pi_{g_i}(e)) \perp_{1/N} \mathcal{X}(\mathbf{C}\pi_{g_j}(e))$

and so $\|P_{\pi_{g_i}(e)}P_{\pi_{g_j}(e)}\|_\infty \leq 1/N$ for all $1 \leq i < j \leq N$. Put $\phi = \varphi \circ \Phi \in \langle M, L(G) \rangle^*$. Since $u_{g_i} \in L(G) \subset M_\varphi$ for all $1 \leq i \leq N$, we have

$$\begin{aligned} \phi(P_e) &= \frac{1}{N} \sum_{i=1}^N \phi(u_{g_i}P_eu_{g_i}^*) = \frac{1}{N} \sum_{i=1}^N \phi(P_{\pi_{g_i}(e)}) = \frac{1}{N} \phi \left(\sum_{i=1}^N P_{\pi_{g_i}(e)} \right) \\ &\leq \frac{1}{N} \left\| \sum_{i=1}^N P_{\pi_{g_i}(e)} \right\|_\phi. \end{aligned}$$

Moreover, we have

$$\begin{aligned} \left\| \sum_{i=1}^N P_{\pi_{g_i}(e)} \right\|_\phi^2 &= \sum_{1 \leq i, j \leq N} \langle P_{\pi_{g_i}(e)}, P_{\pi_{g_j}(e)} \rangle_\phi \\ &\leq \sum_{i=1}^N \|P_{\pi_{g_i}(e)}\|_\phi^2 + \sum_{1 \leq i \neq j \leq N} \|P_{\pi_{g_i}(e)}P_{\pi_{g_j}(e)}\|_\infty \\ &\leq N + \frac{N(N-1)}{N} = 2N - 1. \end{aligned}$$

This implies that $\phi(P_e) \leq \frac{\sqrt{2N-1}}{N}$. Since this is true for every $N \geq 1$, we infer that $\phi(P_e) = 0$ and so $\Phi(P_e) = 0$ since φ is faithful.

Let $e \in K_{\mathbf{R}}$ and $T \in \langle M, L(G) \rangle$. Applying Kadison’s inequality and Claim 5.2, we have

$$\Phi(\ell(e)T)\Phi(\ell(e)T)^* \leq \Phi(\ell(e)TT^*\ell(e)^*) \leq \|T\|^2 \Phi(\ell(e)\ell(e)^*) = 0$$

and so $\Phi(\ell(e)T) = 0$. Likewise, we have $\Phi(T\ell(e)^*) = 0$. Using Wick formula, we obtain $\Phi(W(e_1 \otimes \dots \otimes e_k)) = 0$ for all $k \geq 1$ and all $e_1, \dots, e_k \in K_{\mathbf{R}} + iK_{\mathbf{R}}$. This further implies that $\Phi(M \ominus L(G)) = 0$ and so $P = L(G)$.

(ii). — Along the lines of the proof of item (i), the proof of [34, Theorem 5.1(2)] for $A = L(G)$ and $B = P$ applies *mutatis mutandis* since $P \cap L(G)$ is tracial. We obtain that $P \subset L(G)$. □

Proof of Theorem C.

(i). — This follows from Theorem 5.1(i).

(ii). — Let $P \subset M$ be any von Neumann subalgebra with expectation and with property Gamma such that $P \cap L(G)$ is diffuse. Since $P \subset M$ is with expectation and has property Gamma, [28, Theorem 3.1] implies that there exists a faithful state $\psi \in M_*$ such that P is globally invariant under σ^ψ and there exists a decreasing sequence of diffuse abelian von Neumann subalgebras $A_k \subset P_\psi$ such that $\bigvee_{k \in \mathbf{N}} ((A_k)' \cap P) = P$. Observe that $Q_k = (A_k)' \cap P$ is globally invariant under σ^ψ for every $k \in \mathbf{N}$.

Using Lemma A.5 (i), we have $P' \cap M \subset (P \cap L(G))' \cap M \subset L(G)$ and so $P' \cap M = P' \cap L(G)$. Using [21, Lemma 3.3 (v)], denote by $z^\perp \in P' \cap L(G)$ the largest projection such that $Pz^\perp \prec_M L(G)$. By contradiction, assume that $z^\perp \neq 1$ so that $z = (z^\perp)^\perp \neq 0$. We consider the following two possible situations that will give a contradiction.

Firstly, assume that for every $k \in \mathbf{N}$, we have $A_k z \not\prec_M L(G)$. Using Theorem B.3, we have $(A_k z)' \cap zMz \prec_M L(G)$ and so $Q_k z \prec_M L(G)$ since $Q_k z \subset (A_k z)' \cap zMz$ is with expectation. Since $Q_k z$ is globally invariant under σ^ψ , [31, Remark 3.3] implies that there exists a norm one projection $\Phi_k : z(M, L(G))z \rightarrow Q_k z$ such that $\Phi_k|_{zMz}$ is the unique ψ -preserving conditional expectation. Choose a nonprincipal ultrafilter $\omega \in \beta(\mathbf{N}) \setminus \mathbf{N}$ and define the completely positive map $\Phi_\omega : z\langle M, L(G) \rangle z \rightarrow Pz$ as the pointwise weak limit along ω of the maps Φ_k . Since $\Phi_\omega|_{zMz}$ is ψ -preserving, it follows that Φ_ω is indeed a norm one projection such that $\Phi_\omega|_{zMz}$ is normal. Therefore, $Pz \prec_M L(G)$ and so $P = Pz^\perp \oplus Pz \prec_M L(G)$ by [21, Lemma 3.3 (v)]. This contradicts the definition of z^\perp .

Secondly, assume that there exists $k \in \mathbf{N}$ such that $A_k z \preceq_M L(G)$. Since $A_k z$ is tracial, there exists $n \geq 1$, a normal $*$ -homomorphism $\rho : A_k z \rightarrow \mathbf{M}_n(L(G))$ and a nonzero partial isometry $v \in \mathbf{M}_{1,n}(zM)\rho(z)$ such that $av = v\rho(a)$ for every $a \in A_k z$. Lemma A.5 (i) implies that $v^*v \in \mathbf{M}_n(L(G))$ and $v^*((A_k z)' \cap zMz)v \subset (v^*v\rho(A_k z))' \cap v^*v\mathbf{M}_n(M)v^*v \subset v^*v\mathbf{M}_n(L(G))v^*v$. For every $\ell \geq k$, since $A_\ell z \subset A_k z$ is a diffuse subalgebra, Lemma A.5 (i) implies that $v^*((A_\ell z)' \cap zMz)v \subset (v^*v\rho(A_\ell z))' \cap v^*v\mathbf{M}_n(M)v^*v \subset v^*v\mathbf{M}_n(L(G))v^*v$. This shows that $v^*z\mathcal{P}zv \subset v^*v\mathbf{M}_n(L(G))v^*v$, where $\mathcal{P} = \bigvee_{k \in \mathbf{N}} ((A_k)' \cap M)$. Since $vv^* \in (A_k z)' \cap zMz \subset z\mathcal{P}z$, we have $vv^*z\mathcal{P}zvv^* \preceq_M L(G)$ and so $z\mathcal{P}z \preceq_M L(G)$. Since $Pz \subset z\mathcal{P}z$ is with expectation, we have $Pz \preceq_M L(G)$ by [20, Lemma 4.8]. Using [21, Proposition 4.10], there exists a nonzero projection $r \in \mathcal{Z}((Pz)' \cap zMz) \subset z(P' \cap M)z \subset z(P' \cap L(G))z$ such that $Pr \prec_M L(G)$. Therefore, $Pz^\perp \oplus Pr \prec_M L(G)$ by [21, Lemma 3.3 (v)]. This contradicts the definition of z^\perp .

Therefore, we have $P \prec_M L(G)$. Applying item (ii) in Theorem 5.1, we obtain $P \subset L(G)$. □

Proof of Application D. — It follows from [9, Corollaire 1.5.7] that $T(M) = G$. Since $G < \mathbf{R}$ is a countable dense subgroup, [9, Théorème 3.4.1] implies that M is a type III₀ factor. Using Theorem 6.1, M is a prime factor and using Theorem 6.2, M has no Cartan subalgebra.

Write $M = N \rtimes G$ and denote by $(u_g)_g$ the canonical unitaries in M implementing the action $\sigma^\pi : G \curvearrowright N$. Denote by $\psi \in M_*$ the canonical

faithful normal state. Observe that for every $g \in G$, we have $\sigma_g^\psi = \text{Ad}(u_g)$. Let $L(G) \subset P \subset M$ be any intermediate von Neumann subalgebra. For every $g \in G$, we have $\sigma_g^\psi(P) = u_g P u_g^* = P$. Since $\sigma^\psi : \mathbf{R} \curvearrowright N$ is continuous with respect to the u -topology and since $G < \mathbf{R}$ is dense, we infer that $\sigma_t^\psi(P) = P$ for every $t \in \mathbf{R}$ and so $P \subset M$ is with expectation by [53]. The previous reasoning implies that any intermediate amenable subalgebra $L(G) \subset P \subset M$ is with expectation and Theorem C (i) implies that $L(G) = P$. □

6. Strong solidity

6.1. Proof of Theorem E

Proof of Theorem E. — We denote by $\varphi \in M_*$ the canonical faithful state. Assume that G is amenable and $\pi : G \curvearrowright H_{\mathbf{R}}$ is a faithful mixing orthogonal representation. Without loss of generality, we may assume that $\ker U = \{0\}$ so that M is a type III₁ factor by Theorem A. Indeed, we may replace $H_{\mathbf{R}}$ by $H_{\mathbf{R}} \oplus (H_{\mathbf{R}} \otimes L_{\mathbf{R}}^2(\mathbf{R}))$, U by $U \oplus (1_{H_{\mathbf{R}}} \otimes \lambda_{\mathbf{R}})$ and π by $\pi \oplus (\pi \otimes 1_{L_{\mathbf{R}}^2(\mathbf{R})})$ so that

$$M = \Gamma(U, \pi)'' \subset \Gamma(U \oplus (1_{H_{\mathbf{R}}} \otimes \lambda_{\mathbf{R}}), \pi \oplus (\pi \otimes 1_{L_{\mathbf{R}}^2(\mathbf{R})}))'' = \mathfrak{M}.$$

Then $M \subset \mathfrak{M}$ is with expectation, $\pi \oplus (\pi \otimes 1_{L_{\mathbf{R}}^2(\mathbf{R})})$ is mixing and \mathfrak{M} is a type III₁ factor by Theorem A. Since solidity is preserved under taking diffuse subalgebras with expectation, up to replacing M by \mathfrak{M} , we may assume that M is a type III₁ factor. By contradiction, assume that M is not solid. Since M is of type III and M is not solid, there exists a diffuse abelian subalgebra with expectation $A \subset M$ such that the relative commutant $P = A' \cap M$ has no nonzero amenable direct summand. Theorem B.3 implies that $A \preceq_M L(G)$. Then Theorem A.5 (iii) implies that $P = A' \cap M \preceq_M L(G)$. Then [21, Proposition 4.10] implies that P has a nonzero amenable direct summand. This is a contradiction.

We now prove that $M = \Gamma(U, \pi)''$ is strongly solid following the proof of [6, Main theorem]. We explain below the appropriate changes that are needed. As before, since strong solidity is preserved under taking diffuse subalgebras with expectation, we may assume that M is a type III₁ factor. By contradiction, assume that M is not strongly solid. Since M is a solid type III factor, the exact same reasoning as in the proof of [6, Main theorem] shows that there exists a diffuse amenable subalgebra with expectation $Q \subset M$ such that $Q' \cap M = \mathcal{Z}(Q)$ and $P = \mathcal{N}_M(Q)''$ has

no nonzero amenable direct summand. Choose a faithful state $\phi \in M_*$ such that $Q \subset M$ is globally invariant under σ^ϕ . Observe that P is also globally invariant under σ^ϕ . Denote by (N, ψ) the unique Araki–Woods factor of type III₁ endowed with any faithful normal state. We borrow notation from Appendix B. Put $\mathcal{M} = c_{\varphi \otimes \psi}(M \overline{\otimes} N)$, $\mathcal{B} = c_{\varphi \otimes \psi}(L(G) \overline{\otimes} N)$, $\mathcal{Q} = \Pi_{\varphi \otimes \psi, \phi \otimes \psi}(c_{\phi \otimes \psi}(Q \overline{\otimes} N))$ and $\mathcal{P} = \Pi_{\varphi \otimes \psi, \phi \otimes \psi}(c_{\phi \otimes \psi}(P \overline{\otimes} N))$. By the claim in the proof of [6, Main theorem], we have $\mathcal{P} \subset \mathcal{N}_{\mathcal{M}}(\mathcal{Q})''$. Since this inclusion is with expectation and since \mathcal{P} has no nonzero amenable direct summand by [5, Proposition 2.8], it follows that $\mathcal{N}_{\mathcal{M}}(\mathcal{Q})''$ has no nonzero amenable direct summand either.

Since the inclusion $L(G) \subset M$ is mixing, since $P = \mathcal{N}_M(Q)''$ has no nonzero amenable direct summand and since $L(G)$ is amenable, a combination of Theorem A.5 (iii) and [21, Proposition 4.10] implies that $Q \not\prec_M L(G)$. Since $Q \not\prec_M L(G)$ and since $Q' \cap M = \mathcal{Z}(Q)$, [32, Theorem A] implies that $\mathcal{Q} \not\prec_{\mathcal{M}} \mathcal{B}$. Fix a nonzero finite trace projection $q \in \mathcal{Q}$ and observe that $q\mathcal{Q}q \not\prec_{\mathcal{M}} \mathcal{B}$. Since $M \overline{\otimes} N$ is a type III₁ factor, \mathcal{M} is a type II_∞ factor. Since $L_{\varphi \otimes \psi}(\mathbf{R}) \subset \mathcal{M}$ is diffuse and with trace preserving conditional expectation, there exists a unitary $u \in \mathcal{U}(\mathcal{M})$ such that $uqu^* \in L_{\varphi \otimes \psi}(\mathbf{R}) \subset \mathcal{B}$. Up to conjugating \mathcal{Q} and \mathcal{P} by $u \in \mathcal{U}(\mathcal{M})$ we may assume that $q \in \mathcal{B}$ and that $q\mathcal{Q}q \not\prec_{\mathcal{M}} \mathcal{B}$. Working inside the type II₁ factor $q\mathcal{M}q$, Theorem B.1 implies that $(\theta_t)_t$ does not converge uniformly to the identity on $\text{Ball}(q\mathcal{Q}q)$. Combining [24, Theorem A] and [1, Lemma 4.6 and Theorem 4.9], the type II₁ factor $q\mathcal{M}q$ has the complete metric approximation property. Moreover, since $L(G) \overline{\otimes} N$ is amenable, the $q\mathcal{M}q$ - $q\mathcal{M}q$ -bimodule $L^2(q\widetilde{\mathcal{M}}q) \ominus L^2(q\mathcal{M}q)$ is weakly contained in the coarse bimodule $L^2(q\mathcal{M}q) \otimes L^2(q\mathcal{M}q)$ (see [24, Section 4]). Combining [6, Proposition 3.7] with [47, Proposition 2.4 and Corollary 2.5], we obtain that the stable normalizer $s\mathcal{N}_{q\mathcal{M}q}(q\mathcal{Q}q)''$ has a nonzero amenable direct summand. Since $q\mathcal{P}q \subset s\mathcal{N}_{q\mathcal{M}q}(q\mathcal{Q}q)''$, it follows that \mathcal{P} has a nonzero amenable direct summand and so does $P \overline{\otimes} N$ by [5, Proposition 4.8]. Then P has a nonzero amenable direct summand. This is a contradiction. □

Proof of Application F. — Combining [24, Theorem A] and [1, Consequence 4.10(c)], M has the complete metric approximation property. Likewise, combining [24, Theorem 3.19] and [39, Corollary 5.15], M has the Haagerup property.

Since π is faithful and mixing, Theorem E implies that M is a strongly solid factor. Let $(t, n) \in \mathbf{R} \times \mathbf{Z}$ be any element such that $U_t \otimes \pi_n = 1$. Since π is mixing, we necessarily have $\pi_n = 1$. This implies that $n = 0$ and so $U_t = 1$. Thus, Theorem A shows that $\text{T}(M) = \ker(U)$. Let $(t_k, n_k) \in \mathbf{R} \times \mathbf{Z}$

be any sequence such that $U_{t_k} \otimes \pi_{n_k} \rightarrow 1$ strongly as $k \rightarrow \infty$. Since π is mixing, the sequence $(n_k)_k$ is necessarily bounded. This implies that $n_k = 0$ for $k \in \mathbf{N}$ large enough and so $U_{t_k} \rightarrow 1$ strongly as $k \rightarrow \infty$. Theorem B implies that $\tau(M) = \tau(U)$.

Denote by $\varphi \in M_*$ the canonical faithful state. Put $N = \Gamma(H_{\mathbf{R}} \otimes K_{\mathbf{R}}, U \otimes 1_{K_{\mathbf{R}}})''$ so that $M = N \rtimes \mathbf{Z}$. Observe that N_φ is a free group factor by [49] since $U \otimes 1_{K_{\mathbf{R}}}$ contains $1_{\mathbf{R}} \otimes 1_{K_{\mathbf{R}}}$ as a subrepresentation and $\dim(K_{\mathbf{R}}) = +\infty$. Observe that $M_\varphi = N_\varphi \rtimes \mathbf{Z}$. We claim that M_φ is a factor. Indeed, since the action $\mathbf{Z} \curvearrowright N$ is mixing, we have $\mathcal{Z}(M_\varphi) \subset L(\mathbf{Z})' \cap (N_\varphi \rtimes \mathbf{Z}) \subset L(\mathbf{Z})$ by Theorem A.5(i). By contradiction, if $\mathcal{Z}(M_\varphi) \neq \mathbf{C}1$, there exists $z \in \mathcal{Z}(M_\varphi) \subset L(\mathbf{Z})$ such that $z \notin \mathbf{C}1$. If we write $z = \sum_{n \in \mathbf{Z}} z_n u_n \in L(\mathbf{Z})$ for its Fourier decomposition, there exists $n \in \mathbf{Z} \setminus \{0\}$ for which $z_n \in \mathbf{C} \setminus \{0\}$. Let $x \in \mathcal{U}(N_\varphi)$ be any unitary such that $\varphi(x) = 0$. Since $xz = zx$, we have $\sigma_n^\pi(x) = x$. For every $k \in \mathbf{N}$, we have $\sigma_{kn}^\pi(x) = x$ and so $\varphi(\sigma_{kn}^\pi(x)x^*) = 1$. Since $\mathbf{Z} \curvearrowright N$ is mixing, we have $\lim_k \varphi(\sigma_{kn}^\pi(x)x^*) = \varphi(x)\varphi(x^*) = 0$. This is a contradiction and so $\mathcal{Z}(M_\varphi) = \mathbf{C}1$. Thus, M_φ is a nonamenable type II_1 factor.

Finally, we show that M is not isomorphic to any free Araki-Woods factor. By contradiction, assume that there exists a strongly continuous orthogonal representation $V : \mathbf{R} \curvearrowright L_{\mathbf{R}}$ such that $\Gamma(U \otimes 1_{K_{\mathbf{R}}}, 1_{H_{\mathbf{R}}} \otimes \pi)'' = M = \Gamma(L_{\mathbf{R}}, V)''$. Denote by $\psi \in M_*$ the free quasi-free state on $M = \Gamma(L_{\mathbf{R}}, V)''$. Since M_φ is nonamenable, [26, Theorem 5.1] implies that there exists a nonzero partial isometry $v \in M$ such that $p = v^*v \in M_\varphi, q = vv^* \in M_\psi$ and $\text{Ad}(v) : (pMp, \varphi_p) \rightarrow (qMq, \psi_q)$ is a state preserving isomorphism (here we simply denote $\varphi_p = \frac{\varphi(p \cdot p)}{\varphi(p)}$ and $\psi_q = \frac{\psi(q \cdot q)}{\psi(q)}$). In particular, we obtain

$$p M_\varphi p = (pMp)_{\varphi_p} \cong (qMq)_{\psi_q} = q M_\psi q.$$

It follows that $q M_\psi q$ is nonamenable and so M_ψ is a free group factor by [49]. This implies that M_φ is an interpolated free group factor [13, 48]. By assumption, the $L(\mathbf{Z})$ - $L(\mathbf{Z})$ -bimodule $L^2(M \ominus L(\mathbf{Z}))$ is disjoint from the coarse $L(\mathbf{Z})$ - $L(\mathbf{Z})$ -bimodule $\ell^2(\mathbf{Z} \times \mathbf{Z})$ (see [25, Section 4] for further details). This implies in particular that the $L(\mathbf{Z})$ - $L(\mathbf{Z})$ -bimodule $L^2(M_\varphi \ominus L(\mathbf{Z}))$ is also disjoint from the coarse $L(\mathbf{Z})$ - $L(\mathbf{Z})$ -bimodule $\ell^2(\mathbf{Z} \times \mathbf{Z})$. Since M_φ is an interpolated free group factor, this contradicts [61, Corollary 7.6] and [51, Proposition 9.2]. \square

6.2. Semisolidity and absence of Cartan subalgebra

Following [20, 40], we say that a σ -finite von Neumann algebra M is *semisolid* if for any von Neumann subalgebra with expectation $Q \subset M$ that has no nonzero type I direct summand, the relative commutant $Q' \cap M$ is amenable. Any nonamenable semisolid factor M is *prime*, that is, M does not split as the tensor product of two diffuse factors. When the countable group G is *virtually abelian*, we prove that the factor $\Gamma(U, \pi)''$ is *semisolid* for any faithful orthogonal representation $\pi : G \curvearrowright H_{\mathbf{R}}$ such that $[U, \pi] = 0$.

THEOREM 6.1. — *Let $U : \mathbf{R} \curvearrowright H_{\mathbf{R}}$ be any strongly continuous orthogonal representation with $\dim H_{\mathbf{R}} \geq 2$. Let G be any virtually abelian countable group and $\pi : G \curvearrowright H_{\mathbf{R}}$ any faithful orthogonal representation such that $[U, \pi] = 0$.*

Then $\Gamma(U, \pi)''$ is a semisolid factor. In particular, $\Gamma(U, \pi)''$ is a prime factor.

Proof. — Put $M = \Gamma(U, \pi)''$ and denote by $\varphi \in M_*$ the canonical faithful state. Since π is faithful and $\dim H_{\mathbf{R}} \geq 2$, M is a nonamenable factor by Theorem A. Let $Q \subset M$ be any von Neumann subalgebra with expectation such that Q has no nonzero type I direct summand. Since $L(G)$ is of type I, [29, Lemma 2.6] (or Lemma 2.2) implies that there exists a diffuse abelian subalgebra with expectation $A \subset Q$ such that $A \not\prec_M L(G)$. Theorem B.3 implies that $A' \cap M$ is amenable. Since $Q' \cap M \subset A' \cap M$ is with expectation, it follows that $Q' \cap M$ is amenable. This shows that M is semisolid. \square

When the countable group G is abelian and π is weakly mixing, we moreover prove that $\Gamma(U, \pi)''$ has no Cartan subalgebra.

THEOREM 6.2. — *Let $U : \mathbf{R} \curvearrowright H_{\mathbf{R}}$ be any strongly continuous orthogonal representation with $\dim H_{\mathbf{R}} \geq 2$. Let G be any abelian countable group and $\pi : G \curvearrowright H_{\mathbf{R}}$ any faithful weakly mixing orthogonal representation such that $[U, \pi] = 0$.*

Then $\Gamma(U, \pi)''$ has no Cartan subalgebra.

Proof. — Put $M = \Gamma(U, \pi)'' = N \rtimes G$ and denote by $\varphi \in M_*$ the canonical faithful state. Since π is faithful and $\dim H_{\mathbf{R}} \geq 2$, M is a nonamenable factor by Theorem A. By contradiction, assume that there exists a Cartan subalgebra $A \subset M$. If $A \not\prec_M L(G)$ and since $A \subset M$ is maximal abelian, we can argue exactly as in the last paragraph of the proof of Theorem E and we obtain that $M = \mathcal{N}_M(A)''$ is amenable. This is a contradiction. Therefore, we must have $A \preceq_M L(G)$. Since the orthogonal representation $\pi : G \curvearrowright H_{\mathbf{R}}$ is weakly mixing, the action $\sigma^\pi : G \curvearrowright (N, \varphi)$ is φ -weakly

mixing. Theorem A.5(i) implies that $\mathcal{QN}_M(\mathbb{L}(G))'' = \mathbb{L}(G)$. In particular, $\mathbb{L}(G) \subset M$ is maximal abelian and singular. Since $A \subset M$ and $\mathbb{L}(G) \subset M$ are both masas with expectation, [29, Theorem 2.5] implies that there exists a partial isometry $w \in M$ such that $p = w^*w \in A$, $q = ww^* \in \mathbb{L}(G)$ and $wAw^* = \mathbb{L}(G)q$. By spatiality and using [45, Lemma 3.5] (see also [28, Proposition 2.3]), since $\mathcal{N}_M(A)'' = M$ and since $\mathcal{N}_M(\mathbb{L}(G))'' = \mathbb{L}(G)$, we obtain

$$\begin{aligned} qMq &= w(\mathcal{N}_M(A)'')w^* = \mathcal{N}_{qMq}(wAw^*)'' = \mathcal{N}_{qMq}(\mathbb{L}(G)q)'' \\ &= q(\mathcal{N}_M(\mathbb{L}(G))'')q = \mathbb{L}(G)q. \end{aligned}$$

Thus, $qMq = \mathbb{L}(G)q$ is amenable and so is M . This is a contradiction. \square

Appendix A. Mixing inclusions

Let (M, φ) be any σ -finite von Neumann algebra endowed with any faithful normal state. Let $B \subset M_\varphi$ be any von Neumann subalgebra. Denote by $E_B : M \rightarrow B$ the unique φ -preserving conditional expectation and put $M \ominus B = \ker(E_B)$. Following [45, Section 3], we say that the inclusion $B \subset M$ is

- φ -mixing if for any uniformly bounded net $(b_k)_k$ in B that converges weakly to 0 as $k \rightarrow \infty$, we have

$$\forall x, y \in M \ominus B, \quad \lim_k \|E_B(x^*b_ky)\|_\varphi = 0.$$

- φ -weakly mixing if there exists a net of unitaries $(u_k)_k$ in B such that

$$\forall x, y \in M \ominus B, \quad \lim_k \|E_B(x^*u_ky)\|_\varphi = 0.$$

We recall the following important examples of φ -mixing (resp. φ -weakly mixing) inclusions (see [45, Section 3]). Let G be any countable group, (N, φ) any σ -finite von Neumann algebra endowed with any faithful normal state and $\sigma : G \curvearrowright (N, \varphi)$ any φ -preserving action. Put $M = N \rtimes G$. Denote by $E_N : M \rightarrow N$ the canonical faithful normal conditional expectation and still denote by φ the faithful state $\varphi \circ E_N \in M_*$. Then $\mathbb{L}(G) \subset M_\varphi$. We say that the action $\sigma : G \curvearrowright (N, \varphi)$ is

- φ -mixing if we have

$$\forall a, b \in N, \quad \lim_{g \rightarrow \infty} \varphi(\sigma_g(x)y) = \varphi(x)\varphi(y).$$

- φ -weakly mixing if there exists a net $(g_k)_k$ in G such that

$$\forall a, b \in N, \quad \lim_k \varphi(\sigma_{g_k}(x)y) = \varphi(x)\varphi(y).$$

By [45, Section 3], if the action $\sigma : G \curvearrowright (N, \varphi)$ is φ -mixing (resp. φ -weakly mixing), then the inclusion $L(G) \subset M$ is φ -mixing (resp. φ -weakly mixing).

Following [6, Section 3], for any inclusion with expectation $Q \subset M$, we define the *stable normalizer* of Q inside M as the von Neumann subalgebra generated by the set

$$s\mathcal{N}_M(Q) = \{x \in M \mid x^*Qx \subset Q \text{ and } xQx^* \subset Q\}.$$

Likewise, following [44, Section 1], we define the *quasi normalizer* of Q inside M as the von Neumann subalgebra generated by the set

$$\mathcal{QN}_M(Q) = \left\{ x \in M \mid \exists x_1, \dots, x_k, xQ \subset \sum_{j=1}^k Qx_j \text{ and } Qx \subset \sum_{j=1}^k x_jQ \right\}.$$

We have the following inclusions $Q \subset \mathcal{N}_M(Q)'' \subset s\mathcal{N}_M(Q)'' \subset \mathcal{QN}_M(Q)'' \subset M$ and they are all with expectation.

We prove technical properties of (weakly) mixing inclusions that generalize the main results of [45, Section 3] (see also [59, Theorem D.4] and [30, Lemma 9.4]). We should point out that compared to [45, Section 3], the faithful normal state φ is no longer assumed to be almost periodic and can be arbitrary.

LEMMA A.1 ([42, Lemma 2.3]). — *Let (M, φ) be any σ -finite von Neumann algebra endowed with any faithful normal state. Let $Q \subset N \subset M_\varphi$ be any von Neumann subalgebras. Denote by $E_N : M \rightarrow N$ the unique φ -preserving conditional expectation and put $M \ominus N = \ker(E_N)$. Assume that $Q' \cap M = Q' \cap N$.*

For every $x \in M \ominus N$, there exists $u \in \mathcal{U}(Q)$ such that $\|uxu^ - x\|_\varphi \geq \|x\|_\varphi$.*

Proof. — The proof is exactly the same as the one of [42, Lemma 2.3] by averaging over $\mathcal{U}(Q)$ and exploiting the condition $Q' \cap M \subset N$. We give the details for the reader’s convenience. Let $x \in M \ominus N$ and define $\mathcal{K}_x \subset M$ as the weak closure in M of the convex hull of the set $\{uxu^* \mid u \in \mathcal{U}(Q)\}$. Since $Q \subset M_\varphi$, the unique element $y \in \mathcal{K}$ of minimal $\|\cdot\|_\varphi$ -norm satisfies $y \in Q' \cap M$ and so $y \in N$. Since $E_N(\mathcal{K}_x) = \{0\}$, we obtain $y = E_N(y) = 0$.

By contradiction, assume that for every $u \in \mathcal{U}(Q)$, we have $\|uxu^* - x\|_\varphi < \|x\|_\varphi$. Then $x \neq 0$ and for every $u \in \mathcal{U}(Q)$, we have $\|x\|_\varphi^2 < 2\Re(\varphi(x^*uxu^*))$. Taking weak limits of convex combinations of elements of the form uxu^* for $u \in \mathcal{U}(Q)$, we obtain $\|x\|_\varphi^2 \leq 2\Re(\varphi(x^*y)) = 0$. This is a contradiction. \square

LEMMA A.2. — *Let (M, φ) be any σ -finite von Neumann algebra endowed with any faithful normal state. Let $B \subset M_\varphi$ be any von Neumann subalgebra. Let $1_P \in B$ be any nonzero projection and $P \subset 1_P B 1_P$ any von Neumann subalgebra for which there exists a net of unitaries $(u_k)_k$ such that*

$$(A.1) \quad \forall x, y \in M \ominus B, \quad \lim_k \|E_B(x^* u_k y)\|_\varphi = 0.$$

Let $\mathcal{K} \subset 1_P L^2(M)$ be any P - B -subbimodule that is of finite trace as a right B -module. Then $\mathcal{K} \subset 1_P L^2(B)$.

Proof. — By contradiction, assume that $\mathcal{K} \not\subset 1_P L^2(B)$. Using [59, Lemma A.1] and up to replacing \mathcal{K} by $P_{L^2(M) \ominus L^2(B)}(\mathcal{K}z)$ where $z \in \mathcal{Z}(B)$ is a large enough projection, we may assume that $\mathcal{K} \subset 1_P L^2(M) \ominus 1_P L^2(B)$ is a nonzero P - B -subbimodule that is finitely generated as a right B -module. Proceeding as in the proof of [29, Theorem 2.3], there exist $n \geq 1$, a nonzero vector $\xi \in \mathbf{M}_{1,n}(\mathcal{K})$ and a normal $*$ -homomorphism $\pi : P \rightarrow \mathbf{M}_n(B)$ such that $a\xi = \xi\pi(a)$ for every $a \in P$. Denote by $E_{\mathbf{M}_n(B)} : \mathbf{M}_n(M) \rightarrow \mathbf{M}_n(B)$ the unique $(\varphi \otimes \text{tr}_n)$ -preserving conditional expectation and put $\mathbf{M}_n(M) \ominus \mathbf{M}_n(B) = \ker(E_{\mathbf{M}_n(B)})$. Letting $\xi^* = J_{\mathbf{M}_n(M)}(\xi) \in L^2(\mathbf{M}_n(M)) \ominus L^2(\mathbf{M}_n(B))$, we have $\xi^* \in \mathbf{M}_{n,1}(J_M \mathcal{K})$, $\xi^* 1_P = \xi^*$ and $\xi^* a = \pi(a)\xi^*$ for every $a \in P$. Write $\xi^* = v|\xi^*|$ for the polar decomposition of ξ^* in the standard form of $\mathbf{M}_n(M)$. Then we have that $v \in \pi(1_P)\mathbf{M}_{n,1}(M1_P)$ is a nonzero partial isometry such that $va = \pi(a)v$ for every $a \in P$. We moreover have that $|\xi^*| \in L^2(M)_+$ and $a|\xi^*| = |\xi^*|a$ for every $a \in P$. First, we prove the following claim.

CLAIM A.3. — *We have $v \in \pi(1_P)\mathbf{M}_{n,1}(B1_P)$ and $P' \cap 1_P M 1_P = P' \cap 1_P B 1_P$.*

Indeed, for every $k \in \mathbf{N}$, we have

$$(v - E_{\mathbf{M}_n(B)}(v))u_k = \pi(u_k)(v - E_{\mathbf{M}_n(B)}(v)).$$

Put $w = (v - E_{\mathbf{M}_n(B)}(v)) \in \mathbf{M}_n(M) \ominus \mathbf{M}_n(B)$. Since $\text{supp}(ww^*) \leq \pi(1_P)$ and since $\pi(u_k) \in \mathcal{U}(\pi(1_P)\mathbf{M}_n(B)\pi(1_P))$ for every $k \in \mathbf{N}$, (A.1) implies

$$\begin{aligned} \|E_{\mathbf{M}_n(B)}(ww^*)\|_{\varphi \otimes \text{tr}_n} &= \|E_{\mathbf{M}_n(B)}(\pi(u_k)ww^*)\|_{\varphi \otimes \text{tr}_n} \\ &= \|E_{\mathbf{M}_n(B)}(wu_k w^*)\|_{\varphi \otimes \text{tr}_n} \rightarrow 0 \text{ as } k \rightarrow \infty. \end{aligned}$$

Therefore, we have $w = 0$ and so $v = E_{\mathbf{M}_n(B)}(v) \in \pi(1_P)\mathbf{M}_{n,1}(B1_P)$. Likewise, let $x \in P' \cap 1_P M 1_P$ be any element. For every $k \in \mathbf{N}$, we have

$$(x - E_B(x))u_k = u_k(x - E_B(x)).$$

Put $y = x - E_B(x) \in 1_P M 1_P \ominus 1_P B 1_P$. Since $\text{supp}(yy^*) \leq 1_P$ and since $u_k \in \mathcal{U}(1_P B 1_P)$ for every $k \in \mathbf{N}$, (A.1) implies

$$\|E_B(yy^*)\|_\varphi = \|E_B(u_k y y^*)\|_\varphi = \|E_B(y u_k y^*)\|_\varphi \rightarrow 0 \text{ as } k \rightarrow \infty.$$

Therefore, we have $y = 0$ and so $x = E_B(x) \in B$. Next, we prove the following claim.

CLAIM A.4. — We have $|\xi^*| \in L^2(B)$.

Indeed, write η for the orthogonal projection of $|\xi^*|$ onto $L^2(M) \ominus L^2(B)$. We show that $\eta = 0$. We still have $a\eta = \eta a$ for every $a \in P$. Since $\eta \in L^2(M) \ominus L^2(B)$, since $1_P \eta 1_P = \eta$ and since $1_P \in M_\varphi$, we may choose a sequence $x_j \in M \ominus B$ such that $1_P x_j 1_P = x_j$ for every $j \in \mathbf{N}$ and $x_j \xi_\varphi \rightarrow \eta$ as $j \rightarrow \infty$. Note that $(x_j)_j$ need not be uniformly bounded. Since $P' \cap 1_P M 1_P = P' \cap 1_P B 1_P$ by Claim A.3, Lemma A.1 implies that for every $j \in \mathbf{N}$, there exists a unitary $u_j \in \mathcal{U}(P)$ such that $\|u_j x_j u_j^* - x_j\|_\varphi \geq \|x_j\|_\varphi$. Then for every $j \in \mathbf{N}$, we have

$$\begin{aligned} 2\|\eta - x_j \xi_\varphi\| &\geq \|u_j(\eta - x_j \xi_\varphi) u_j^* - (\eta - x_j \xi_\varphi)\| \\ &= \|u_j x_j \xi_\varphi u_j^* - x_j \xi_\varphi\| \\ &= \|u_j x_j u_j^* - x_j\|_\varphi \\ &\geq \|x_j\|_\varphi. \end{aligned}$$

Since $\lim_j \|\eta - x_j \xi_\varphi\| = 0$, we have $\lim_j \|x_j\|_\varphi = 0$ and so $\eta = 0$. This shows that $|\xi^*| \in L^2(B)$.

Combining Claims A.3 and A.4, we obtain that $\xi^* = v|\xi^*| \in L^2(B)$. Since by construction $\xi^* \in L^2(M) \ominus L^2(B)$, we obtain $\xi^* = 0$ and so $\xi = 0$. This is a contradiction. □

THEOREM A.5. — Let (M, φ) be any σ -finite von Neumann algebra endowed with any faithful normal state. Let $B \subset M_\varphi$ be any von Neumann subalgebra. The following assertions hold:

- (i) Assume that the inclusion $B \subset M$ is φ -weakly mixing. Then $\mathcal{QN}_M(B)'' = B$.
- (ii) Assume that the inclusion $B \subset M$ is φ -mixing. Let $1_P \in B$ be any nonzero projection and $P \subset 1_P B 1_P$ any diffuse von Neumann subalgebra. Then $\mathcal{QN}_{1_P M 1_P}(P)'' \subset 1_P B 1_P$.
- (iii) Assume that the inclusion $B \subset M$ is φ -mixing. Let $1_Q \in M$ be any nonzero projection and $Q \subset 1_Q M 1_Q$ any diffuse von Neumann subalgebra with expectation. If $Q \preceq_M B$, then $\mathcal{N}_{1_Q M 1_Q}(Q)'' \preceq_M B$.

Proof.

(i). — Since the inclusion $B \subset M$ is φ -weakly mixing, there exists a net of unitaries $(u_k)_k$ in B such that (A.1) holds. Lemma A.2 implies that $\mathcal{QN}_M(B)'' = B$.

(ii). — Since P is diffuse, we may choose a net of unitaries $(u_k)_k$ in P that converges weakly to 0 as $k \rightarrow \infty$. Since the inclusion $B \subset M$ is φ -mixing, (A.1) holds for the net $(u_k)_k$. Lemma A.2 implies that $\mathcal{QN}_{1_P M 1_P}(P)'' \subset 1_P B 1_P$.

(iii). — Since $Q \preceq_M L(G)$, there exist projections $q \in Q$ and $p \in L(G)$, a unital normal $*$ -homomorphism $\pi : qQq \rightarrow pL(G)p$ and a nonzero partial isometry $v \in pMq$ such that $av = v\pi(a)$ for every $a \in qQq$. Note that $vv^* \in (qQq)' \cap qMq \subset \mathcal{QN}_{qMq}(qQq)''$ and $v^*v \in \pi(qQq)' \cap pMp \subset pBp$ using item (ii). For every $x \in \mathcal{QN}_{qMq}(qQq)$, it is straightforward to see that $v^*xv \in \mathcal{QN}_{pMp}(\pi(qQq))$ and so $v^*\mathcal{QN}_{qMq}(qQq)''v \subset pBp$ using item (ii). This shows that $vv^*\mathcal{QN}_{qMq}(qQq)''vv^* \preceq_M B$ and so $\mathcal{QN}_{qMq}(qQq)'' \preceq_M B$. Since $s\mathcal{N}_{qMq}(qQq)'' \subset \mathcal{QN}_{qMq}(qQq)''$ is with expectation and since $q(s\mathcal{N}_M(Q)'')q = s\mathcal{N}_{qMq}(qQq)''$ (see [6, Lemma 3.4]), this implies that $q(s\mathcal{N}_M(Q)'')q \preceq_M B$ and so $s\mathcal{N}_M(Q)'' \preceq_M B$ (see [20, Lemma 4.8]). Since $\mathcal{N}_M(Q)'' \subset s\mathcal{N}_M(Q)''$ is with expectation, we finally obtain $\mathcal{N}_M(Q)'' \preceq_M B$ by [20, Lemma 4.8]. □

Appendix B. Popa’s deformation/rigidity theory

Popa’s malleable deformation

Let $U : \mathbf{R} \curvearrowright H_{\mathbf{R}}$ be any strongly continuous orthogonal representation. Let G be any countable group and $\pi : G \curvearrowright H_{\mathbf{R}}$ any orthogonal representation such that $[U, \pi] = 0$. Let (N, ψ) be any σ -finite von Neumann algebra endowed with a faithful normal state. Define

- $M = \Gamma(U, \pi)''$ and φ the canonical faithful normal state on $\Gamma(U, \pi)''$.
- $\widetilde{M} = \Gamma(U \oplus U, \pi \oplus \pi)''$ and $\widetilde{\varphi}$ the canonical faithful normal state on $\Gamma(U \oplus U, \pi \oplus \pi)''$.
- $\mathcal{M} = (M \overline{\otimes} N) \rtimes_{\varphi \otimes \psi} \mathbf{R}$, the continuous core of $M \overline{\otimes} N$ with respect to $\varphi \otimes \psi$.
- $\widetilde{\mathcal{M}} = (\widetilde{M} \overline{\otimes} N) \rtimes_{\widetilde{\varphi} \otimes \psi} \mathbf{R}$, the continuous core of $\widetilde{M} \overline{\otimes} N$ with respect to $\widetilde{\varphi} \otimes \psi$.
- $\mathcal{B} = (L(G) \overline{\otimes} N) \rtimes_{\varphi \otimes \psi} \mathbf{R}$, the continuous core of $L(G) \overline{\otimes} N$ with respect to $\varphi \otimes \psi$.

We can regard $\widetilde{\mathcal{M}}$ as the semifinite amalgamated free product von Neumann algebra

$$\widetilde{\mathcal{M}} = ((M \overline{\otimes} N) \rtimes_{\varphi \otimes \psi} \mathbf{R}) *_{\mathcal{B}} ((M \overline{\otimes} N) \rtimes_{\varphi \otimes \psi} \mathbf{R}),$$

where we identify \mathcal{M} with the left copy of $(M \overline{\otimes} N) \rtimes_{\varphi \otimes \psi} \mathbf{R}$ inside the amalgamated free product. We simply denote by τ the canonical faithful normal semifinite trace on \mathcal{M} and by $\|\cdot\|_2$ the 2-norm associated with τ . Consider the following orthogonal transformations on $H_{\mathbf{R}} \oplus H_{\mathbf{R}}$:

$$W = \begin{pmatrix} 1 & 0 \\ 0 & -1 \end{pmatrix} \quad \text{and} \quad V_t = \begin{pmatrix} \cos(\frac{\pi}{2}t) & -\sin(\frac{\pi}{2}t) \\ \sin(\frac{\pi}{2}t) & \cos(\frac{\pi}{2}t) \end{pmatrix}, \quad \forall t \in \mathbf{R}.$$

Define the associated state preserving deformation (θ_t, β) on $\widetilde{M} \overline{\otimes} N$ by

$$\theta_t = \text{Ad}(\mathcal{F}(U_t)) \otimes \text{id}_N \quad \text{and} \quad \beta = \text{Ad}(\mathcal{F}(V)) \otimes \text{id}_N.$$

Since V_t and W commute with $\pi \oplus \pi$ and $U \oplus U$, it follows that θ_t and β commute with the actions $(\sigma^\pi * \sigma^\pi) \otimes \text{id}_N$ and $\sigma^{\varphi \otimes \psi}$. We can then extend the deformation (θ_t, β) to $\widetilde{\mathcal{M}}$ after defining $\beta|_{\mathcal{B}} = \text{id}_{\mathcal{B}}$ and $\theta_t|_{\mathcal{B}} = \text{id}_{\mathcal{B}}$ for every $t \in \mathbf{R}$. Moreover, it is easy to check that the deformation (θ_t, β) is malleable in the sense of Popa (see [45]):

- (i) $\lim_{t \rightarrow 0} \|x - \theta_t(x)\|_2 = 0$ for all $x \in \widetilde{\mathcal{M}} \cap L^2(\widetilde{\mathcal{M}})$.
- (ii) $\beta^2 = \text{id}_{\widetilde{\mathcal{M}}}$ and $\theta_t \beta = \beta \theta_{-t}$ for all $t \in \mathbf{R}$.

Since $\theta_t, \beta \in \text{Aut}(\widetilde{\mathcal{M}})$ are trace-preserving, we will also denote by $\theta_t, \beta \in \mathcal{U}(L^2(\widetilde{\mathcal{M}}))$ the corresponding Koopman unitary operators.

Locating subalgebras

We can locate subalgebras of \mathcal{M} for which the deformation $(\theta_t)_t$ converges uniformly to the identity with respect to $\|\cdot\|_2$ on the unit ball.

THEOREM B.1 ([24, Theorem 4.3], [18, Theorem 2.10]). — *Keep the same notation as above. Let $p \in \mathcal{M}$ be any nonzero finite trace projection and $\mathcal{P} \subset p\mathcal{M}p$ any von Neumann subalgebra. If the deformation $(\theta_t)_t$ converges uniformly in $\|\cdot\|_2$ on $\text{Ball}(\mathcal{P})$, then $\mathcal{P} \preceq_{\mathcal{M}} \mathcal{B}$.*

Proof. — Since the deformation $(\theta_t)_t$ converges uniformly in $\|\cdot\|_2$ on $\text{Ball}(\mathcal{P})$, there exist $\kappa > 0$ and $n \in \mathbf{N}$ large enough so that $\tau(\theta_{2^{-n}}(u)u^*) \geq \kappa$ for all $u \in \mathcal{U}(\mathcal{P})$. Now the rest of the proof is almost entirely identical to the one of [24, Theorem 4.3] except for some obvious modifications.

By contradiction, assume that $\mathcal{P} \not\preceq_{\mathcal{M}} \mathcal{B}$ and choose a net of unitaries $u_k \in \mathcal{U}(\mathcal{P})$ such that $\lim_k \|E_{\mathcal{B}}(b^*u_k a)\|_2 = 0$ for all $a, b \in p\mathcal{M}$. Using

Popa’s malleable deformation in combination with [5, Theorem 2.5] (in lieu of [8, Theorem 2.4]), there exists a nonzero partial isometry $v \in p\widetilde{\mathcal{M}}\theta_1(p)$ such that $vv^* \in p\mathcal{M}p$, $v^*v \in \theta_1(p\mathcal{M}p)$ and $xv = v\theta_1(x)$ for every $x \in \mathcal{P}$. Using [5, Claim in the proof of Theorem 3.3] (in lieu of [24, Claim 4.4]), we infer that

$$\begin{aligned} \|v^*v\|_2 &= \|E_{\theta_1(\mathcal{M})}(v^*v)\|_2 = \lim_k \|E_{\theta_1(\mathcal{M})}(v^*v\theta_1(u_k))\|_2 \\ &= \lim_k \|E_{\theta_1(\mathcal{M})}(v^*u_kv)\|_2 = 0. \end{aligned}$$

This contradicts the fact that $v \neq 0$. Thus, we have $\mathcal{P} \preceq_M \mathcal{B}$. □

Popa’s spectral gap rigidity

We prove the following general spectral gap rigidity result inside \mathcal{M} .

THEOREM B.2 ([18, Theorem 6.5]). — *Keep the same notation as above. Let $p \in \mathcal{M}$ be any nonzero finite trace projection and $\mathcal{Q} \subset p\mathcal{M}p$ any von Neumann subalgebra. Then at least one of the following assertions is true:*

- *There exists a nonzero projection $z \in \mathcal{Z}(\mathcal{Q}' \cap p\mathcal{M}p)$ such that $\mathcal{Q}z \prec_{\mathcal{M}} \mathcal{B}$.*
- *The deformation $(\theta_t)_t$ converges uniformly in $\|\cdot\|_2$ on $\text{Ball}(\mathcal{Q}' \cap p\mathcal{M}p)$.*

Proof. — We follow the proof of [21, Theorem A.1]. Assume that the deformation $(\theta_t)_t$ does not converge uniformly in $\|\cdot\|_2$ on $\text{Ball}(\mathcal{Q}' \cap p\mathcal{M}p)$. Then there exist $c > 0$, a sequence $(t_k)_k$ of positive reals such that $\lim_k t_k = 0$ and a sequence $(x_k)_k$ in $\text{Ball}(\mathcal{Q}' \cap p\mathcal{M}p)$ such that $\|x_k - \theta_{2t_k}(x_k)\|_2 \geq c$ for all $k \in \mathbf{N}$.

Denote by I the directed set of all pairs $(\varepsilon, \mathcal{F})$ with $\varepsilon > 0$ and $\mathcal{F} \subset \text{Ball}(\mathcal{Q})$ finite subset with order relation \leq defined by

$$(\varepsilon_1, \mathcal{F}_1) \leq (\varepsilon_2, \mathcal{F}_2) \quad \text{if and only if} \quad \varepsilon_2 \leq \varepsilon_1, \mathcal{F}_1 \subset \mathcal{F}_2.$$

Let $i = (\varepsilon, \mathcal{F}) \in I$ and put $\delta = \min(\frac{\varepsilon}{4}, \frac{\varepsilon}{8})$. Choose $k \in \mathbf{N}$ large enough so that $\|p - \theta_{t_k}(p)\|_2 \leq \delta$ and $\|a - \theta_{t_k}(a)\|_2 \leq \varepsilon/4$ for all $a \in \mathcal{F}$.

Put $\xi_i = \theta_{t_k}(x_k) - E_{\mathcal{M}}(\theta_{t_k}(x_k)) \in L^2(\widetilde{\mathcal{M}}) \ominus L^2(\mathcal{M})$ and $\eta_i = p\xi_i p \in L^2(p\widetilde{\mathcal{M}}p) \ominus L^2(p\mathcal{M}p)$. By the transversality property of the malleable deformation $(\theta_t)_t$ (see [46, Lemma 2.1]), we have

$$\|\xi_i\|_2 \geq \frac{1}{2} \|x_k - \theta_{2t_k}(x_k)\|_2 \geq \frac{c}{2}.$$

Observe that $\|p\theta_{t_k}(x_k)p - \theta_{t_k}(x_k)\|_2 \leq 2\|p - \theta_{t_k}(p)\|_2 \leq 2\delta$. Since $p \in \mathcal{M}$, by Pythagoras theorem, we moreover have

$$\|p\theta_{t_k}(x_k)p - \theta_{t_k}(x_k)\|_2^2 = \|\mathbb{E}_{\mathcal{M}}(p\theta_{t_k}(x_k)p - \theta_{t_k}(x_k))\|_2^2 + \|\eta_i - \xi_i\|_2^2$$

and hence $\|\eta_i - \xi_i\|_2 \leq 2\delta$. This implies that

$$\|\eta_i\|_2 \geq \|\xi_i\|_2 - \|\eta_i - \xi_i\|_2 \geq \frac{c}{2} - 2\delta \geq \frac{c}{4}.$$

For all $x \in p\mathcal{M}p$, we have

$$\|x\eta_i\|_2 = \|(1 - \mathbb{E}_{\mathcal{M}})(x\theta_{t_k}(x_k)p)\|_2 \leq \|x\theta_{t_k}(x_k)p\|_2 \leq \|x\|_2.$$

By Popa’s spectral gap argument [46], for all $a \in \mathcal{F} \subset \text{Ball}(\mathcal{Q}) \subset \text{Ball}(p\mathcal{M}p)$, since $ax_k = x_ka$ for all $k \in \mathbf{N}$, we have

$$\begin{aligned} \|a\eta_i - \eta_i a\|_2 &= \|(1 - \mathbb{E}_{\mathcal{M}})(a\theta_{t_k}(x_k)p - p\theta_{t_k}(x_k)a)\|_2 \\ &\leq \|a\theta_{t_k}(x_k)p - p\theta_{t_k}(x_k)a\|_2 \\ &\leq 2\|a - \theta_{t_k}(a)\|_2 + 2\|p - \theta_{t_k}(p)\|_2 \\ &\leq \frac{\varepsilon}{2} + \frac{\varepsilon}{2} = \varepsilon. \end{aligned}$$

Thus $\eta_i \in L^2(p\widetilde{\mathcal{M}}p) \ominus L^2(p\mathcal{M}p)$ is a net of vectors satisfying $\limsup_i \|x\eta_i\|_2 \leq \|x\|_2$ for all $x \in p\mathcal{M}p$, $\liminf_i \|\eta_i\|_2 \geq \frac{c}{4}$ and $\lim_i \|a\eta_i - \eta_i a\|_2 = 0$ for all $a \in \mathcal{Q}$.

By construction of the amalgamated free product von Neumann algebra $\widetilde{\mathcal{M}} = \mathcal{M} *_B \mathcal{M}$, there exists a \mathcal{B} - \mathcal{L} -bimodule such that we have $L^2(\widetilde{\mathcal{M}}) \ominus L^2(\mathcal{M}) \cong L^2(\mathcal{M}) \otimes_B \mathcal{L}$ as \mathcal{M} - \mathcal{M} -bimodules (see e.g. [56, Section 2]). The existence of the net $(\eta_i)_{i \in I}$ in combination with [28, Lemma A.2] shows that there exists a nonzero projection $z \in \mathcal{Z}(\mathcal{Q}' \cap p\mathcal{M}p)$ such that $\mathcal{Q}z \prec_{\mathcal{M}} \mathcal{B}$. \square

We deduce the following spectral gap rigidity result inside $M \overline{\otimes} N$.

THEOREM B.3. — *Keep the same notation as above. Let $A \subset M \overline{\otimes} N$ be any abelian von Neumann subalgebra with expectation.*

If $A \not\prec_{M \overline{\otimes} N} (L(G) \overline{\otimes} N)$, then $A' \cap (M \overline{\otimes} N) \prec_{M \overline{\otimes} N} (L(G) \overline{\otimes} N)$.

Proof. — Choose a faithful state $\phi \in (M \overline{\otimes} N)_*$ such that $A \subset (M \overline{\otimes} N)_\phi$. Observe that $Q = A' \cap (M \overline{\otimes} N)$ is globally invariant under σ^ϕ . Assume that Q is not amenable relative to $L(G) \overline{\otimes} N$ inside $M \overline{\otimes} N$. Put $c(Q) = \Pi_{\varphi \otimes \psi, \phi}(c_\phi(Q)) \subset \mathcal{M}$. Using [31, Theorem 3.2], $c(Q)$ is not amenable relative to \mathcal{B} inside \mathcal{M} . Using [21, Lemma 3.3], there exists a nonzero finite trace projection $q \in L_\phi(\mathbf{R})$ such that $\Pi_{\varphi \otimes \psi, \phi}(q) c(Q) \Pi_{\varphi \otimes \psi, \phi}(q)$ is not amenable relative to \mathcal{B} inside \mathcal{M} . Using again [21, Lemma 3.3], there exists a nonzero projection $p \in \mathcal{Z}((\Pi_{\varphi \otimes \psi, \phi}(q) c(Q) \Pi_{\varphi \otimes \psi, \phi}(q))' \cap \Pi_{\varphi \otimes \psi, \phi}(q) \mathcal{M} \Pi_{\varphi \otimes \psi, \phi}(q))$ such that with $\mathcal{Q} = p c(Q) p$, we have that $\mathcal{Q}z$ is not amenable relative to \mathcal{B}

inside \mathcal{M} for any nonzero projection $z \in \mathcal{Z}(\mathcal{Q}' \cap p\mathcal{M}p)$. Theorem B.2 implies that the deformation $(\theta_t)_t$ converges uniformly in $\|\cdot\|_2$ on $\text{Ball}(\mathcal{Q}' \cap p\mathcal{M}p)$. Since $\Pi_{\varphi \otimes \psi, \phi}(\pi_\phi(A))p \subset \mathcal{Q}' \cap p\mathcal{M}p$ is a von Neumann subalgebra, the deformation $(\theta_t)_t$ converges uniformly in $\|\cdot\|_2$ on $\text{Ball}(\Pi_{\varphi \otimes \psi, \phi}(\pi_\phi(A))p)$. Theorem B.1 implies that $\Pi_{\varphi \otimes \psi, \phi}(\pi_\phi(A))p \preceq_{\mathcal{M}} \mathcal{B}$. Since $p = \Pi_{\varphi \otimes \psi, \phi}(q)p$, we have $\Pi_{\varphi \otimes \psi, \phi}(\pi_\phi(A)q) \preceq_{\mathcal{M}} \mathcal{B}$. Then [27, Lemma 2.4] implies that $A \preceq_{M \bar{\otimes} N} \text{L}(G) \bar{\otimes} N$. \square
